# **Program Summary**

For most people who live in New Jersey, the New Jersey Motor Vehicle Commission (MVC) is the most widely known State agency. This program will cover the history and background of the MVC, the areas that the MVC regulates, and licensing and registrations, including an overview of Operation Facial Scrub. The presenters will also address recent developments at the MVC, including transactions that have moved online (pre- and post-pandemic), REAL ID, status neutral licensing, and transportation network companies.

### **Eligibility**

This program is open to attorneys in the Department of Law and Public Safety and county prosecutors' offices. Registrants will receive the course materials prior to the program date.

#### **Faculty**

**DAG** Amy Chung is an Assistant Section Chief of the Transportation, Construction & Condemnation (TCC) Section of the Division of Law and represents the New Jersey Department of Transportation and the New Jersey Motor Vehicle Commission. Previously, she was an Assistant Section Chief of the Treasury-Finance & Benefits Section, where she handled complex pensions and health benefits matters; she also was a line deputy in the TCC Section. DAG Chung has briefed and argued more than 30 appeals in federal and State courts, including five in the

Supreme Court of New Jersey. She clerked for the Honorable Karen Nelson Moore of the U.S. Court of Appeals for the Sixth Circuit and graduated from Harvard Law School and Harvard-Radcliffe Colleges.

**DAG Jennifer Jaremback** serves in the Division of Law's Transportation, Construction & Condemnation (TCC) Section, where she primarily represents the New Jersey Motor Vehicle Commission (MVC). She advises the MVC on a variety of matters that impact its statutory and regulatory authority, and reviews regulations and agreements. She has also briefed and argued a number of cases before the Superior Court, Appellate Division, and litigates matters in the New Jersey Office of Administrative Law and the Superior Court. Before joining the TCC Section, DAG Jaremback served in the Division of Law's DCF Practice Group, where she litigated child abuse and neglect matters. DAG Jaremback clerked in Mercer County Superior Court for the Honorable Maria M. Sypek, P.J.Cr. She graduated magna cum laude from The College of New Jersey, and received her J.D. from Rutgers University School of Law.
