## WEBINAR

### *Program Summary*

This program will update SPEC and Employment Counseling Deputies on what employers need to know about New Jersey law regarding employee use of marijuana.

### *Eligibility*

Registration for this program is limited to Deputy and Assistant Attorneys General in the State Police, Employment & Corrections and Employment Counseling Sections of the Division of Law. Registrants will receive the course materials prior to the program date.

### *Faculty*

**DAG Agnes I. Rymer** is an Assistant Section Chief in the State Police, Employment & Corrections Section of the Division of Law. Prior to joining DOL, she was in private practice in general civil litigation. She clerked in the United States District Court for the District of New Jersey, for Hon. H. Lee Sarokin (retired) and holds a J.D. from Rutgers Law School, Newark.

**DAG Jana R. DiCosmo** is a member of the Employment Counseling and Labor Section of the Division of Law, where she represents the State and its agencies in employment-related matters, including discrimination complaints filed with the New Jersey Division on Civil Rights and the Equal Employment Opportunity Commission. Prior to joining the Office of the Attorney General, DAG DiCosmo worked at the Delaware Department of Labor's Office of Anti-Discrimination,

investigating charges of discrimination filed against Delaware employers. DAG DiCosmo also served as the Department's liaison to the Delaware Employment First Oversight Commission, which worked to improve employment opportunities for disabled Delaware residents. DAG DiCosmo served as an Equal Justice Works AmeriCorps Taishoff fellow at the Delaware Law School's Veterans Law Clinic, representing disabled veterans in disability benefits appeals. She interned for the Honorable Harold U. Johnson, J.S.C. while in her final semester of law school and clerked for the Honorable Mary K. White, J.S.C. (ret.) after graduation. She holds a J.D. from Widener University Delaware Law School.
