# Policing Lessons from the Holocaust What You Do Matters

### **Program Summary**

This program examines policing within the legal and political framework of Nazi Germany - a journey that eventually turned those who should protect life and liberty into those who intimidated, humiliated, deported, and eventually murdered millions of innocent people. The study of the Holocaust provides an important insight into the consequences that can occur when the government shifts the mission of the police from protecting individuals to a policy of abusing basic human rights. How Germany changed in less than a decade from a free, democratic, and scientifically advanced society to a totalitarian regime that systematically targeted and murdered millions of its own citizens is a lesson a free society must learn – or be destined to repeat the same mistakes of the past. Using historical images and stories from the Holocaust, trained facilitators will engage prosecutors and law enforcement officers in a dialogue about the role of law enforcement in today's communities and the importance of core values in ensuring the integrity and vibrancy of democracy.

## Eligibility

This program is open to County Prosecutors and Assistant Prosecutors, Division of Criminal Justice Assistant and Deputy Attorneys General, Department of Law and Public Safety executive staff and law enforcement officers from their respective offices invited to attend. Registrants will receive the course materials on the day of the program.

#### Faculty

**Elizabeth Ortiz. Esq.** is the Executive Director the Arizona Prosecuting Attorneys' Advisory Council (APAAC), which she joined as its Senior Staff Attorney. She was previously a prosecutor for the Maricopa County, Arizona Attorney's Office, where she served as a Bureau Chief in the Juvenile, Pretrial, Charging, and Appeals Units. Ms. Ortiz has also served as a sworn special prosecutor for La Paz, Maricopa, Navajo, and Pinal counties in Arizona. She serves on several committees for the State Bar of Arizona and is a board member for the National Association of Prosecution Coordinators, the National District Attorneys Association, the Commission of Victims in the Courts, the Commission to Prevent Violence Against Women, and the Arizona Forensic Science Academy. Ms. Ortiz teaches extensively throughout Arizona, the United States, and in Mexico. After graduating from law school, she clerked at the Arizona Court of Appeals. Ms. Ortiz holds a Bachelor of Science in Economics, a Master of Arts in Political Science and a Juris Doctor from Arizona State University.

**Lt. David Moore** is a member of the Phoenix, Arizona Police Department, where he currently serves as a patrol lieutenant. He has previously served in the Traffic, Violent Crimes, Professional Standards, Training, and Information & Technology Bureaus and the Vehicular Homicide Unit. Lt. Moore is a Master Facilitator for *What You Do Matters: Lessons from the Holocaust*. He holds a B.S. in Criminal Justice from Wayland Baptist University and an M.S. in Organizational Leadership from Northern Arizona University
