## WEBINAR

### *Program Summary*

Twenty years ago, the world first met Harry Potter. Although at that time, young Harry was living under a staircase, over the next ten years Muggles everywhere watched him grow up to be the Rules of Professional Conduct's "citizen with a special responsibility for the quality of justice." In this program, travel with the young wizard through J.K. Rowling's popular series and encounter Harry's lessons on rules, justice, forgiveness, honor, and the magic in practicing law.

With humor and insight, Professor Greg Randall Lee analogizes lawyers to wizards and explains:

- How we can use our "magic" to make the world a better place.
- Why words matter.
- Why no opportunity to do good should ever be wasted.
- Why lawyers bear responsibility for community.
- Why we should be inspired by others, but also be a source of inspiration.
- Why we should be personally involved in our clients' matters, but not take things personally.
- Why we should stand with people who have no one else to stand with them and understand that the world you save, is a world worth saving.
- Why the mechanisms of justice should be used as a means to restore, rather than to extract revenge.

### *Eligibility*

This program is open to attorneys in the Department of Law and Public Safety and county prosecutors' offices. Registrants will receive the course materials prior to the program date.

### *Faculty*

**Professor Greg Randall Lee** teaches Constitutional Law, Professional Responsibility, and Torts at the Widener University Commonwealth School of Law in Harrisburg, Pennsylvania. He has been selected as Widener's Outstanding Law Professor by both students and alumni. Professor Lee has served as the chair of both the Association of American Law Schools' Section on Professional Responsibility and the law school subcommittee of the Pennsylvania Bar Association Professionalism Committee. He has given over three hundred talks in a host of different forums and published over 50 law-related articles. He holds an undergraduate degree from Butler University and a J.D. from Harvard Law School.
