# Current Trends in Diagnostic Testing Schemes: An Introduction to VNG Testing and TCD Studies to Identify and Prove Medical Provider Fraud

# **Program Summary**

This presentation will cover the latest developments in diagnostic testing schemes, including the use of Infrared/Video ENG Testing (VNG testing) and Transcranial Doppler (TCD) studies billed by No-Fault providers. The program will examine New Jersey and New York provider billings to illustrate just how clever fraud schemes have become in recent years. Discussion will include a brief introduction to the clinical justification and purpose of each type of test, performance requirements and necessary equipment. The presenter will then outline tips and techniques to identify fraud in the testing, including effectively using insurers' data, scrutinizing providers' reports and bills, determining what to look for at clinic inspections and what questions to ask claimants at a recorded statement or EUO. The presenter will also discuss the criminal and civil statutes relating to fraudulent diagnostic testing to provide attendees with the legal framework to build their medical provider fraud case.

#### **Eligibility**

#### **Faculty**

She works closely with attorneys and consulting and expert witnesses, including physicians, statisticians, and forensic accountants, to develop various types of proofs used in litigation. Ms. Smith presents regularly at insurance industry conferences devoted to combating fraud and provides training on anti-fraud techniques, solutions, and strategies to SIU and claims personnel and investigators from law enforcement agencies. Ms. Smith graduated *summa cum laude* from Rutgers Law School. She also holds an MBA from Rowan University and is a Certified Fraud Examiner (CFE) and a Fraud Claims Law Specialist (FCLS).
