### *Program Summary*

This course will provide a brief overview of the most significant criminal appeals likely to be argued in the New Jersey Supreme Court during the 2022-2023 Court Term.

### *Eligibility*

This program is designed for attorneys in the Division of Criminal Justice and county prosecutors' offices. However, it is open to all deputy and assistant attorneys general in the Department of Law and Public Safety. Registrants will receive the course materials prior to the program date.

### *Faculty*

**DAG Catlin Davis** serves in the Appellate Bureau of the Division of Criminal Justice, where she litigates criminal appeals in the Appellate Division and Supreme Court. She is a member of the Bureau's working groups on Evidence, Search and Seizure, and Sentencing. Prior to joining the Division, DAG Davis clerked in the Law Division for the Honorable Kevin M. Shanahan, P.J.Cv., and the Appellate Division for the Honorable Robert J. Gilson, J.A.D. She received a B.A. from St. John's College, and a J.D. from Vermont Law School, summa cum laude.

**DAG Amanda Schwartz** serves in the Division of Criminal Justice's Appellate Bureau, where she litigates criminal appeals in the Appellate Division and Supreme Court. She is a member of the Bureau's working groups on DNA/CODIS, Search and Seizure, and Miranda Warnings. Prior to joining the Division, DAG Schwartz clerked for the Honorable Patrick DeAlmeida, J.A.D.,

while he was the Presiding Judge of the Tax Court and a judge in the Appellate Division. She received a B.A. from the College of Staten Island and a J.D. from Seton Hall Law School, cum laude.
