### **Defending Against Employer Liability In Hostile Work Environment Cases**

## WEBINAR

### *Program Summary*

This program will cover what employment lawyers need to know regarding employer liability in hostile work environment claims brought under the Law Against Discrimination. The presenters will discuss vicarious and direct liability, and the defenses that are available to employers, including those addressed by the Court in Aguas v. State of New Jersey, 220 N.J. 494 (2013). The presenters will cover the different theories of liability, the elements of the defenses detailed in Aguas, and how courts have applied them since the 2013 decision.

### *Eligibility*

### *Faculty*

AAG Cohen holds a B.A. in Political Science, magna cum laude, from Colorado College and a J.D from the University of Denver, Sturm College of Law, where she was a member of the law review.
