# **Program Summary**

This program will provide DCF deputies with additional Solution Based Casework (SBC) training. The presenters will summarize and explain solution based casework, including which matters are likely to be brought to court and how to incorporate SBC language into court presentations. They will provide specific case examples and utilize role play to assist deputies in understanding the implication of SBC changes for court. The presenters will also discuss how the Department of Children and Families is working to transition from a Compliance Case Practice Model to a Behavioral Change Case Practice Model.

#### **Eligibility**

### **Faculty**

**Erin Frasso** is a County Services Specialist in the Division of Child Protection and Permanency (DCPP) at the New Jersey Department of Children and Families (DCF). Her responsibilities include critical incident and child fatality reviews and expungement coordination. Ms. Frasso is also involved in special projects related to division initiatives, including the implementation of Solution Based Casework. She was selected as a Solution Based Casework "Champion" for the department and a Solution Based Casework Trainer for DCF staff. Ms. Frasso has previously

served within DCPP as a Screener, Investigator, Adoption Specialist and Intake Supervisor. Prior to joining DCF, she was a Community Resource Specialist at a social services organization where she trained fellow staff and volunteers. Ms. Frasso earned a Bachelor of Arts in Psychology and Sociology from the University of Rhode Island and a Master of Arts in Child Advocacy and Child Public Welfare from Montclair State University. She also holds an Adoption Certification from the Rutgers School of Social Work.

**Jim Corbett** is a Supervisor of the Case Practice Liaisons in the Assistant Commissioner's Office of the Division of Child Protection and Permanency. He is a Solution Based Casework Champion and a graduate of the Data Fellows and the Violence Against Women programs. Mr. Corbett holds a Bachelor's degree in Sociology with a concentration in Criminal Justice from Bloomfield College a Master's Degree in Human Services Administration from Rider University.
