Program Summary

This presentation will provide an in-depth review of Grand Jury practice. The presenter will discuss the function of the grand jury, preliminary matters and the Brooke Murphy process. The presenter will also cover presenting testimony, tactical considerations, when to present exculpatory evidence pursuant to the Supreme Court holding in State v. Hogan and how to properly charge the grand jury.

Eligibility

This program is mandatory for new assistant prosecutors and Division of Criminal Justice deputies hired after October 2021 who have been selected to attend by each county prosecutor's office and the Division of Criminal Justice. Other assistant prosecutors and Division of Criminal Justice deputies are welcome to register. Registrants will receive the course materials prior to the program date.

Faculty

Lynne Krug is an Assistant Prosecutor with the Essex County Prosecutor's Office, where she is a member of the Grand Jury Unit. She has presented hundreds of cases; including attempted murders, car jackings, robberies, aggravated assaults, financial crimes, and narcotic offenses. She has also presented specialty matters involving target presentations and superseding indictments. AP Krug was previously the Essex County Police Legal Advisor, which required 24/7 availability to any county law enforcement officer who had a legal question or needed other assistance. This position also included teaching police, corrections, special law enforcement officer, deputy sheriff and auxiliary police recruits at the police academy and providing in-service training to active officers. AP Krug also spent approximately five years assigned to the Narcotics

Task Force and many years assigned to the Adult Trial Team, where she managed a caseload numbering over 100 cases from the initial complaint stage through plea negotiations, motion practice, trials, sentencing proceedings and post-conviction relief matters. She holds a B.A. from Montclair State University and a J.D. from Rutgers Law School.
