Program Summary

This presentation will assist students in preparing to introduce exhibits correctly and persuasively. Students will learn how to develop convincing and legal foundations for various exhibits and how to use exhibits in examining witnesses. Skills covered will include showing the purpose for which the exhibit will be introduced, laying a persuasive foundation for the exhibit, laying a legal foundation for the exhibit and using the exhibit after it has been introduced.

Eligibility

This program is mandatory for new assistant prosecutors and Division of Criminal Justice deputies hired after October 2021 who have been selected to attend by each county prosecutor's office and the Division of Criminal Justice. Other assistant prosecutors and deputy and assistant attorneys general in the Divisions of Criminal Justice and Law are also welcome to register. Registrants will receive the course materials prior to the program date.

Faculty

John McNamara, Jr. is an adjunct professor at Seton Hall Law School. He retired from the Morris County Prosecutor's Office in 2022. He served as a Chief Assistant Prosecutor, where he oversaw the Appellate and Special Investigations Units. He previously served as the Supervising Assistant Prosecutor of the Professional Standards Unit and as Chief of the Major Crimes Unit as its supervising attorney. Mr. McNamara has prosecuted numerous homicide cases on behalf of the Morris County Prosecutor's Office, including capital cases before the abolition of the penalty in 2007. He has served as a Special Deputy Attorney General in the contested proceeding before the N.J. Supreme Court-appointed Special Master examining whether New Jersey should modify the admissibility standards for eyewitness identification testimony. He has also served as amicus curiae counsel on behalf of the County Prosecutors Association of New Jersey (CPANJ) and argued on its behalf before the N.J. Supreme Court.

Mr. McNamara initially joined the Morris County Prosecutor's Office under Prosecutor John B. Dangler. He briefly left the office for private practice before returning. Prior to working for the MCPO, he was an Assistant District Attorney for New York County under Robert M. Morgenthau, where his assignments included prosecuting homicide cases in the Homicide Bureau. Mr. McNamara served for five terms as a member of the New Jersey Supreme Court Committee on Model Criminal Jury Charges, and is a member of the New Jersey Supreme Court Criminal Practice Committee. He holds a B.A. and M.A. in History from the University of Scranton and a J.D. from the Catholic University of America Columbus School of Law and served as a judicial clerk to the Hon. Donald G. Collester, Jr., J.A.D.
