Program Summary

This program will provide a comprehensive overview of FN litigation, including the role of a DAG representing a Department of Children and Families Division Local Office and the knowledge and skills a DAG must master to advocate on behalf of the Division in FN matters. The presenters will cover all areas of substantive practice in FN litigation, including OSC, ROSC, case management conferences, Fact Finding trials, stipulations, compliance reviews, dispositional hearings and permanency hearings. The presenters will also discuss the basics of trial presentation, including direct and cross examination, evidence objections and soliciting expert testimony. Deputies will be provided with strategies for effective trial preparation and guidance on managing the client, the adversary and the court.

Eligibility

This program is only open to Deputy Attorneys General in the Division of Law's DCF practice group.

Faculty

DAG Deirdre Carver is assigned to the DCF-Central Section of the Division of Law. She handles termination of parental rights and abuse or neglect cases. Prior to joining the Division of Law, she worked as a public defender in Virginia and in private practice, focusing on medical malpractice cases. DAG Carver clerked in the Appellate Division for the late Hon. Arnold M. Stein, J.A.D. She graduated from Fairfield University and Seton Hall University School of Law, where she was Editor-in-Chief of the Seton Hall Legislative Journal.

DAG Katelynn Reilly is assigned to the Division of Child Protection and Permanency Mercer County North Local Office. She represents the Division in termination of parental rights and abuse/neglect cases. While in law school, she worked full-time as the Discovery Manager for a plaintiff's personal injury firm in Philadelphia. After law school, she clerked for the Hon. Donald J. Stein, assisting in Children in Court matters in Camden County. She holds a Bachelor's Degree from Penn State University and a J.D. from Rutgers Law School.

DAG Eliezer Sanchez-Silver is assigned to the Division of Child Protection and Permanency Southern Monmouth County Local Office, where he handles an FN docket. He has also represented the Division in both protective services and guardianship litigation. DAG Sanchez-Silver earned a B.A. from Rutgers University and a J.D. from Brooklyn Law School, where he was an Edward V. Sparer Public Interest fellow.
