Program Summary

A panel of former federal judicial clerks will provide an overview of litigation before the U.S. Supreme Court. The presenters (one of whom is slated to argue *New York v. New Jersey* before the Court on March 1) will share their insights about Supreme Court practice, including how the Court chooses which cases to hear from the roughly 5,000-6,000 petitions for certiorari it receives, how it acts on emergency motions (sometimes called "the shadow docket"), and what briefing and argument look like in the 60-70 cases the Court hears argument on each year. The presenters will also discuss the briefs, arguments, and opinions in some major civil and criminal cases pending before or recently decided by the Supreme Court this Term.

Eligibility

Faculty

AAG Jeremy Feigenbaum is the State Solicitor General. Before joining the Department of Law & Public Safety, he was an associate at Kirkland & Ellis in New York. He also served as an adjunct professor at NYU School of Law. Solicitor General Feigenbaum clerked for Judge William Fletcher of the U.S. Court of Appeals for the Ninth Circuit and Justice Elena Kagan of the U.S. Supreme Court. He graduated from Brown University and Harvard Law School.

AAG Michael Zuckerman is a Deputy State Solicitor General. Before joining the Department of Law & Public Safety, he was a Skadden Fellow and Litigation Counsel at the Ohio Justice & Policy Center and a Visiting Assistant Professor at The Ohio State University's Moritz College of Law in Columbus, Ohio. Deputy Solicitor General Zuckerman previously clerked for U.S. Supreme Court Justice Sonia Sotomayor and for Judge Karen Nelson Moore on the U.S. Court of Appeals for the Sixth Circuit. He graduated from Harvard College and Harvard Law School, where he was president of the Harvard Law Review.

AAG Angela Cai is a Deputy State Solicitor General. Before joining the Department of Law & Public Safety, she was an associate at Wilkinson Stekloff LLP in New York and Paul, Weiss, Rifkind, Wharton & Garrison in Washington, D.C. Deputy Solicitor General Cai clerked for Judge Michael Chagares of the U.S. Court of Appeals for the Third Circuit and Judge Katherine B. Forrest of the U.S. District Court for the Southern District of New York. She graduated from Princeton University and Yale Law School.
