# WEBINAR

#### **Program Summary**

This program will cover recent appellate trends impacting the DCF Practice Group, with a focus on the Appellate Division's interpretation of the July 2021 Amendments to the KLG Act, Title 30 and Title 9, including <u>DCP&P v. DCA</u>, 474 N.J. Super. 11 (App. Div. 2022). The panelists will discuss common defense arguments and how the amendments impact presentation of evidence, client advice, resource parent preference, expert testimony, and best interest analysis. The presenters will also provide an overview of all published FN and FG case law from 2021-2022, with trial practice tips and practical guidance on filing and opposing interlocutory appeals.

#### Eligibility

This program is only open to Deputy and Assistant Attorneys General in the DCF practice group and DCF agency attorneys invited to attend.

#### Faculty

**DAG Mary L. Harpster** is a member of the Division of Law's Department of Children and Families Appeals Section, where she drafts appellate briefs and oppositions to petitions for certification, handles a heavy motion practice, and conducts oral advocacy. Her work includes three affirmative appeals challenging a trial court's interpretation of the July 2021 amendments to Title 9, Title 30, and the KLG Act, and the recently published decision in <u>DCP&P v. D.C.A.</u>, 474 N.J. Super. 11 (App. Div. 2022). Prior to joining the DCF Appellate Section, DAG Harpster was a member of the DCF Essex Section, handling FN, FG, and FC cases for six local offices. Before practicing law, she worked in nonprofit theater management; most recently as the Deputy Director of the Alliance of Resident Theatres/New York, an advocacy organization for New York City's

nonprofit theater companies, where she created and managed two loan funds, six re-grant funds, and two technical assistance programs for the Alliance's 350 member theaters. DAG Harpster holds a J.D. from NYU School of Law.

**DAG Leah A. Schmidt** is a member of the Division of Law's Department of Children and Families Appeals Section, where she researches and drafts briefs before the Appellate Division and N.J. Supreme Court and conducts oral advocacy in DCF matters including child abuse and neglect and termination of parental rights cases. She has represented the Division of Child Protection and Permanency (DCPP) in FN, FG and FC cases in multiple counties, provided training to local DCPP offices, tried hundreds of child protection cases and argued several appeals before New Jersey appellate courts. Prior to joining DOL, DAG Schmidt was an associate at the law office of Thaniel J. Beinert & Associates in Brooklyn, NY. Before practing law, she was an Americorps NCCC associate in Colorado, New Mexico, Iowa, and Illinois, where she completed a variety of service projects designed to strengthen local communities. DAG Schmidt holds a J.D. from New York Law School.
