### *Program Summary*

This program will provide an overview of using Sanction trial presentation software during trials and other court proceedings, including the powerful benefits of utilizing this software to present a case. The presenters will discuss some of the practical aspects of preparing a Sanction case for trial, such as tips on planning ahead, collaborating with the trial team, equipment considerations and using the software to prepare witnesses for testimony. They will also incorporate examples of exhibits and synchronized recordings used in actual trials and a discussion on trial strategy and the use of exhibits during witness testimony and summations.

### *Eligibility*

This program is designed for deputies in the Division of Criminal Justice, the Office of Public Integrity & Accountability, the Office of the Insurance Fraud Prosecutor and assistant county prosecutors. Although the presenters will focus on the use of Sanction in criminal trials, deputies from the Division of Law are welcome to register.

## *Faculty*

**AAG Anthony A. Picione** is the Deputy Director of the New Jersey Department of Law & Public Safety's Office of Public Integrity and Accountability. Previously, AAG Picione was the Deputy Chief and then the Chief of the Division of Criminal Justice's Corruption and Government Fraud Bureau for over a decade. AAG Picione's practice concentrates on white-collar crime, particularly offenses involving public officials. During his career, AAG Picione has prosecuted numerous high profile cases involving public corruption and the theft of public funds. AAG Picione is also an instructor for the New Jersey Attorney General's Advocacy Institute, the National Attorneys General Research and Training Institute, and the New Jersey Police Training Commission, as well as an Adjunct Professor of Trial Advocacy for Rutgers Law School. AAG Picione received a J.D. *cum laude* from the University of Pennsylvania Law School and a B.A. *magna cum laude* from Drew University.

**Nathalie Kurzawa** is an analyst in the New Jersey Department of Law & Public Safety's Division of Criminal Justice, Gangs South Unit. She previously worked for DCJ's Corruption Bureau, Money Laundering Unit, and in Financial Crimes. Nathalie is a Certified Sanction 5.0 Operator and XMAN Spotlight Analyst and been trained in New Jersey Regional Intelligence Certified Analysis and FinCen Financial Analysis. She has assisted in over 40 trials for many different units including cyber, financial, corruption, gangs, environmental and the Motor Vehicle Commission.
