### WEBINAR

#### *Program Summary*

The Middle Atlantic Great Lakes Organized Crime Law Enforcement Network (MAGLOCLN) is a part of the Regional Information Sharing System (RISS), a federally funded organization comprised of six regional centers. MAGLOCLN offers law enforcement agencies and their attorneys and officers a full range of diverse and far-reaching services and programs to assist them from the beginning of an investigation through trial and its resources can provide significant assistance in apprehending, prosecuting and convicting criminals. Those resources include cell phone analysis, searching intelligence databases, retrieving information from investigative systems, providing assistance from research staff, utilizing surveillance equipment, conducting training, producing charts and other graphics that can be used at trial, and providing analysts to interpret information, testify at trials and explain their work to juries. The presenters will discuss services offered by MAGLOCLN that can assist prosecutors in effectively investigating and trying cases.

#### *Eligibility*

This program is open to County Prosecutors and Assistant Prosecutors and Deputy Attorneys General in the Department of Law and Public Safety's Division of Criminal Justice.

#### *Faculty*

**Steven Tori** is the Senior Supervisory Intelligence Analyst with the Middle Atlantic-Great Lakes Organized Crime Law Enforcement Network (MAGLOCLN). He guides a team of seven intelligence analysts who support 1,500 MAGLOCLN agencies with a wide variety of analytical products and services, providing strategic and tactical support to law enforcement agencies

throughout the Mid Atlantic-Great Lakes region. Mr. Tori has provided direct analytical support to over 2,400 criminal investigations, utilizing techniques including telephone toll, cellular antenna, link, and financial analysis. He also has extensive experience creating crime scene diagrams, both scaled and non-scaled, for use as demonstrative aids in court. In addition to tactical case analysis and support, Mr. Tori was MAGLOCLEN's primary drug and narcotics analyst for over 12 years, producing eight editions of MAGLOCLEN's biennial *Regional Drug Price & Purity Report*, as well as nine intelligence reports and several strategic threat assessments. He holds a Bachelor's Degree in Criminal Justice from Temple University in Philadelphia, PA. He earned a professional analytical certification in 2003, and a lifetime analyst certification in 2011.

**Angelo Fiumara** is the Field Operations and Training Manager for the Middle Atlantic-Great Lakes Organized Crime Law Enforcement Network (MAGLOCLEN). Prior to that, he was the Deputy CTO in Regional Information Sharing Systems Program's Office of Information Technology. He served in the Sensitive But Unclassified Networks Information Sharing Group, partnering with organizations at all levels of law enforcement to develop standards and policy related to federated identity between information sharing systems. He was previously a member of the New Castle County Delaware police department, working as a patrol officer and in the Criminal Investigations, SWAT, Evidence Detection and Records Units. He has been an adjunct professor at Delaware Technical and Community College and a certified police instructor. Mr. Fiumara has completed courses in Information Resources Management, Business Data Communications, Principles of Business Intelligence, Enterprise Systems Implementation, Configuration, and Administration, Integrated Enterprise Information Systems and Enterprise Networks for Information Systems.
