# What Deputies Should Know About "Daniel's Law"

### **Program Summary**

Daniel's Law is a New Jersey statute that protects the personal information of active or retired judges, prosecutors, law enforcement officers, and their immediate family members. Government agencies, individuals, and businesses are prohibited from publishing the home address and telephone numbers of individuals who request protection under Daniel's Law. The presenters will provide an overview of Daniel's Law, including who it covers, what deputies should do when they suspect it has been violated and remedies for violation of its prohibitions.

## Eligibility

Registration for this program is limited to deputy and assistant attorneys general in the State Police, Employment and Corrections and Tort Litigation and Judiciary Sections of the Division of Law.

### Faculty

**AAG Frank Kapusinski** is an Assistant Attorney General in the Division of Law's Litigation Practice Group. Prior to joining DOL, he served as Assistant Bergen County Counsel, including seven years as the county's Chief of Litigation. Before entering public service, AAG Kapusinski was in private practice, primarily focusing on commercial litigation. He earned a B.A. from Seton Hall University and a J.D. from Rutgers School of Law.

**DAG Thomas F. Sindel, Jr.** is a member of the Tort Litigation and Judiciary Section in the Division of Law, handling matters in both State and federal courts. Prior to joining the TL&J section, he clerked for the Honorable J. Randall Corman, J.S.C. in the Middlesex Vicinage—Civil

Division. He received a Bachelor of Science in Business Administration, *summa cum laude*, from Rider University, and a J.D., from the Maurice A. Deane School of Law at Hofstra University. He was selected to participate in Hofstra's Clinical Prosecution Practicum at the Suffolk County District Attorney's Office, where he prosecuted a misdemeanor caseload under a student practice order. He was also the Managing Editor of Staff of his law school's trust and estate law journal.

**DAG Leah Traub** is a member of the State Police, Employment & Corrections Section in the Division of Law, where she defends State agencies, including the New Jersey State Police and the Department of Corrections in civil litigation lawsuits ranging from civil rights violations to employment discrimination. She also appears in State and federal court; files and argues motions and briefs, takes depositions and prepares discovery demands. Prior to joining DOL, DAG Traub was an assistant prosecutor in Camden County, where she was assigned to the Trial Team Unit, and an assistant prosecutor in Cumberland County, where she was a member of the Special Victims and Grand Jury Units. She clerked for the Honorable Gary D. Wodlinger in Cumberland County. DAG Traub has a B.A. in Psychology from Rutgers University Camden and a J.D. from Widener University School of Law in Wilmington, Delaware.
