## WEBINAR

### ***Program Summary***

Cellular location data is one of a prosecutor's most potent, if complex, tools. This program will explore the capabilities and legal implications of location data so prosecutors can use it effectively. The presenters will discuss the foundations of cellular technology, the uses/limits of location data for investigation and trial, motion practice and qualifying an expert, trial presentation strategies, cross-examination, and emerging technologies and strategies.

### ***Eligibility***

This program is open to County Prosecutors and Assistant Prosecutors and Deputy Attorneys General in the Department of Law and Public Safety's Division of Criminal Justice.

### ***Faculty***

**Executive Assistant Prosecutor Rick McKelvey** supervises the Atlantic County Prosecutor's Office legal staff and Community Outreach Team and handles litigation and trials for homicide cases. He also conducts training for assistant prosecutors and local police departments, coordinates the police department liaison program and developed the county's At-Risk Initiative, Mental Health Diversion, and Violence Interruption Program. EAP McKelvey previously served as Chief Assistant Prosecutor of the Litigation Section, and as an assistant prosecutor in the Major Crimes Unit, where he prosecuted murders, vehicular homicides, and drug-induced deaths. He has argued before the Appellate Division and New Jersey Supreme Court and is an Adjunct Professor at Stockton University. EAP McKelvey holds a B.A. in English from Rider University and a J.D. from Rutgers Law School.

**Special Agent John Hauger** is assigned to the Federal Bureau of Investigation's Cellular Analysis Survey Team as a National Asset. He has successfully used cellular telephone analysis to locate and apprehend fugitives, recover victims, and corroborate investigations in numerous state and federal cases. Special Agent Hauger has consulted with local, state and federal law enforcement and prosecutors on thousands of cases involving cellular telephone record analysis. He provides cellular analysis instruction/training to law enforcement officers around the country and has been qualified as an expert in historical cell site location analysis in New Jersey and courts throughout the United States. He has testified as an expert 140 times. Special Agent Hauger holds a B.S. from West Chester University.
