Program Summary

In <u>State in the Interest of E.S.</u>, 252 <u>N.J.</u> 331 (2022), the New Jersey Supreme Court addressed juvenile waiver motions under 2A:4A-26.1 and related suppression motion practice in Family Court, including the timing and venue of suppression motions in juvenile matters in which waiver motions have been filed. This program will examine the holding in *E.S.*. The instructors will discuss the surrounding case law in relation to juvenile waiver motions and the strategic implications of when and before which Court related suppression motions are litigated.

Eligibility

Registration for this program is limited to Cumberland County assistant prosecutors.

Faculty

Harold B. Shapiro is the First Assistant Prosecutor for Cumberland County. He previously served in the Juvenile and Special Litigation Units, including as Team Leader and Section Chief of the Juvenile Unit. He holds a Bachelor of Arts degree in Business Management from St. Joseph's University and a Juris Doctor from Rutgers Law School – Camden.

Assistant Prosecutor Veronica A. Byrd is a member of the Juvenile Unit at the Cumberland County Prosecutor's Office. Prior to joining the Cumberland County Prosecutor's office, she clerked for the Honorable Thomas T. Booth J.S.C., of the Camden County Superior Court. AP Byrd graduated Cum Laude with a Bachelor of Arts degree in Sociology from Spelman College and holds a Juris Doctor from Rutgers University Law School.
