### **Grand Jury Issues**

### **WEBINAR**

#### *Program Summary*

This presentation will provide an in-depth review of grand jury practice. The presenter will discuss the function of the grand jury, preliminary matters and the Brooke Murphy process. She will also cover presenting testimony, tactical considerations, when to present exculpatory evidence pursuant to the Supreme Court holding in *State v. Hogan* and how to properly charge the grand jury.

#### *Eligibility*

This program is mandatory for new assistant prosecutors and Division of Criminal Justice deputies hired after October 2022 who have been selected to attend by each county prosecutor's office and the Division of Criminal Justice. Other assistant prosecutors and Division of Criminal Justice deputies are welcome to register.

#### *Faculty*

**Lynne Krug** is an Assistant Prosecutor with the Essex County Prosecutor's Office, where she is a member of the Pre-Indictment Unit. She has presented hundreds of cases; including attempted murders, car jackings, robberies, aggravated assaults, financial crimes, and narcotic offenses. She has also presented specialty matters involving target presentations and superseding indictments. AP Krug was previously the Essex County Police Legal Advisor, which required on-call availability to answer legal questions or requests for assistance from any county law enforcement officer. She taught police, corrections, and special law enforcement officers, deputy sheriffs and auxiliary police recruits at the police academy and provided in-service training to active officers. AP Krug was also assigned to the Narcotics Task Force and the Adult Trial Team, where she managed a caseload of over 100 cases from the initial complaint stage through

plea negotiations, motion practice, trials, sentencing proceedings and post-conviction relief matters. She holds a B.A. from Montclair State University and a J.D. from Rutgers Law School.
