### **Program Summary**

Client Services are an integral part of the practice of law. To a large degree, your success as an attorney is linked to how well you can meet the needs of your client. This program covers your responsibilities in representing clients. It will also address time keeping practices designed to better assist both deputies and their clients.

#### Eligibility

This program is mandatory for Division of Law Deputy Attorneys General hired after April 2023 who have not previously completed the Basic Civil and Administrative Practice (BCAP) series of courses. DOL deputies who are required to take this program must register for all BCAP sessions.

Other Division of Law deputies are welcome to attend this program.

#### **Faculty**

**Michael T.G. Long** is the Director of the Division of Law. DAG Moratti worked in private practice for several years before joining the Division. She completed a federal clerkship with the late Hon. Jerome B. Simandle, U.S.D.J., and holds a B.S. in Marketing from Villanova University and a J.D. from Rutgers Law School – Camden.

**DAG** Merav Lichtenstein is the incoming Office Manager for the Division of Law's Newark office. She will supervise attorney assistants, investigators, and operations supervisors and perform other operational responsibilities for that office. DAG Lichtenstein is also an assistant section chief in the DOL's Department of Children and Families Essex Section. She was previously a line deputy for that section, conducting guardianship and child abuse/neglect trials. Prior to joining DOL, DAG Lichtenstein clerked for the Honorable Thomas Weisenbeck, A.J.S.C. in Morris County. She holds an undergraduate degree from Emory University and a J.D. from the Benjamin N. Cardozo School of Law of Yeshiva University.
