# WEBINAR

## **Program Summary**

This course will provide a primer on trial preparation, including a framework for the steps necessary to get a case ready for trial. The presenters will discuss the challenges that frequently arise during trial preparation, common objections and how to overcome them and provide a brief overview of some common trial issues, including motions to bar experts, late discovery, and motions for mistrial.

## Eligibility

This program is mandatory for new assistant prosecutors and Division of Criminal Justice deputies hired after October 2022 who have been selected to attend by each county prosecutor's office and the Division of Criminal Justice. Other assistant prosecutors and Division of Criminal Justice deputies are welcome to register.

### Faculty

**DAG Heather Hausleben** is the Deputy Chief of the Corruption Bureau in the Office of Public Integrity and Accountability, where she oversees the investigation and prosecution of crimes committed by and involving public officials, as well as public contract fraud. She was previously assigned to the Gangs and Organized Crimes Bureau of the Division of Criminal Justice, handling cases involving racketeering, distribution of controlled dangerous substances, weapons offenses, and human trafficking. In both roles, DAG Hausleben worked with OPIA's Integrity Bureau, where she was responsible for investigations involving police use of force and deaths in custody. She served as a law clerk for Camden County Superior Court Judge Samuel Natal. DAG Hausleben holds a Bachelor's of Arts in Philosophy from the University of South Florida and a Juris Doctor from Seton Hall Law School.

**Danielle R. Grootenboer** is a Senior Assistant Prosecutor in the Bergen County Prosecutor's Office, where she serves as an SAP for complex cases and supervises assistant prosecutors in homicide and other difficult cases. She previously served as Chief of the BCPO's Narcotics Task Force, Domestic Violence Unit and Homicide Squad and worked in the Major Crimes Unit and Grand Jury and Trial Sections. Senior Assistant Prosecutor Grootenboer has tried approximately one hundred jury trials, most of which have been complex first-degree cases, including homicides. She has conducted in-service programs for the BCPO, instructed police recruits, provided training to municipal police officers on Fourth Amendment issues and served as faculty for the New Jersey Attorney General's Advanced Domestic Violence and Top Gun Programs. In 2019, the County Prosecutors Association of New Jersey recognized Senior Assistant Prosecutor Grootenboer for outstanding advocacy over a career. She also received a Lifetime Achievement Award from the New Jersey Women in Law Enforcement. Senior Assistant Prosecutor Grootenboer holds a Bachelor's of Arts in Political Science and French, *cum laude*, from Fordham University and a Juris Doctor from Seton Hall Law School, where she was the Notes & Surveys Editor for the Seton Hall Legislative Journal.
