# WEBINAR

### **Program Summary**

Selecting a jury is of the utmost importance. This presentation will offer practical guidance on how to effectively choose a jury, as well as examine ethical problems and considerations in jury selection. The presenter will address the impact of social media in jury selection, crafting questions with a purpose, the importance of organization, and the use of challenges. The program will also cover the recent implementation of Attorney Conducted Voir Dire, which will change the jury selection process. The presenter will address these changes and discuss two recent NJ Supreme Court cases: State v. Andujar and State v. Little.

### **Eligibility**

This program is mandatory for new assistant prosecutors and Division of Criminal Justice deputies hired after October 2022 who have been selected to attend by each county prosecutor's office and the Division of Criminal Justice. Other assistant prosecutors and Division of Criminal Justice deputies are welcome to register.

## **Faculty**

**Danielle R. Grootenboer** is a Senior Assistant Prosecutor in the Bergen County Prosecutor's Office, where she serves as an SAP for complex cases and supervises assistant prosecutors in homicide and other difficult cases. She previously served as Chief of the BCPO's Narcotics Task Force, Domestic Violence Unit and Homicide Squad and worked in the Major Crimes Unit and Grand Jury and Trial Sections. Senior Assistant Prosecutor Grootenboer has tried approximately one hundred jury trials, most of which have been complex first-degree cases, including homicides. She has conducted in-service programs for the BCPO, instructed police recruits, provided training

to municipal police officers on Fourth Amendment issues and served as faculty for the New Jersey Attorney General's Advanced Domestic Violence and Top Gun Programs. In 2019, the County Prosecutors Association of New Jersey recognized Senior Assistant Prosecutor Grootenboer for outstanding advocacy over a career. She also received a Lifetime Achievement Award from the New Jersey Women in Law Enforcement. Senior Assistant Prosecutor Grootenboer holds a Bachelor's of Arts in Political Science and French, *cum laude*, from Fordham University and a Juris Doctor from Seton Hall Law School, where she was the Notes & Surveys Editor for the Seton Hall Legislative Journal.
