### **Executive Branch Ethics Requirements for LPS Employees**

### **WEBINAR**

#### *Program Summary*

This program will examine State government executive branch ethics requirements, with an emphasis on ethics issues that affect Department of Law and Public Safety employees. The program will cover the Conflicts of Interest Law, N.J.S.A. 52:13D-12 et seq., ethics rules, N.J.A.C.19:6.1 et seq., the Uniform Ethics Code and ethics-related executive orders. The presenters will discuss additional ethics requirements from the Department of Law and Public Safety Supplementary Ethics Code, illustrated with case studies from LPS that address common ethics dilemmas.

**This program will satisfy the 2023 mandatory ethics training requirement for Department of Law and Public Safety employees.**

#### *Eligibility*

This program is open to all employees in the Department of Law and Public Safety.

#### *Faculty*

**AAG Melissa Liebermann** is the Department of Law & Public Safety's Chief Ethics & Compliance Officer. She provides ethics advice and counsel to department employees on the application of the Conflicts of Interest Law, the Uniform Ethics Code, the LPS Supplementary Ethics Code, the Rules of Professional Conduct and other ethics standards. AAG Liebermann was previously Chief of Staff and Counsel to the Attorney General. Before joining LPS, she served in the Office of the State Comptroller as Chief of Staff and Deputy State Comptroller, where she oversaw audits of government programs and investigations of government employee misconduct.

Prior to working for the OSC, AAG Liebermann was an Assistant Counsel to the Governor and a litigation associate at a large New Jersey law firm. AAG Liebermann began her legal career as a Deputy Attorney General in the Division of Law, representing the Division of Consumer Affairs. She clerked for J.A.D. Philip S. Carchman (ret.). She holds a B.A. in Political Science from Tufts University and a J.D. with honors from Rutgers School of Law-Newark.

**DAG Regan Barbetti** serves in the Department of Law & Public Safety's Office of Ethics and Compliance. Before joining LPS, she was the Ethics Compliance Officer and a legal specialist for the New Jersey State Ethics Commission. Prior to her State service, DAG Barbetti was a partner at the law firm of Goldstein Bachman & Newman, where she practiced family law. She worked at the law firm of Graham Curtin in Morristown and began her legal career at Wilson, Elser, Moskowitz, Edelman & Dicker in Newark. DAG Barbetti clerked for Presiding Judge E. David Millard in Ocean County. She holds a B.S. in Administration from Villanova University and a J.D. from Seton Hall Law School.
