# WEBINAR

### **Program Summary**

This course will cover the legal and practical considerations that a prosecutor should know about jurors and jury trials. The presenter will examine issues that may arise in the context of either *voir dire* or during the deliberative process, and will identify practice points regarding jury selection. The presenter will also highlight areas of potential concern for litigators, to lessen their learning curve if such issues arise by happenstance in the middle of a trial.

## Eligibility

This program is designed for assistant prosecutors and Division of Criminal Justice deputy attorneys general, but civil litigation attorneys are welcome to attend.

### Faculty

**John McNamara, Jr**. is an adjunct professor at Seton Hall Law School. He retired from the Morris County Prosecutor's Office in 2022, where he served as a Chief Assistant Prosecutor, overseeing the Appellate and Special Investigations Units. He previously served as the Supervising Assistant Prosecutor of the Professional Standards Unit and as Chief of the Major Crimes Unit as its supervising attorney. Mr. McNamara has prosecuted numerous homicide cases on behalf of the Morris County Prosecutor's Office, including capital cases before the abolition of the penalty in 2007. He has served as a Special Deputy Attorney General in the contested proceeding before the N.J. Supreme Court-appointed Special Master examining whether New Jersey should modify the admissibility standards for eyewitness identification testimony. He has also served as amicus curiae counsel on behalf of the County Prosecutors Association of New Jersey and argued on its behalf before the N.J. Supreme Court.

Mr. McNamara initially joined the Morris County Prosecutor's Office under Prosecutor John B. Dangler. He briefly left the office for private practice before returning. Prior to working for the MCPO, he was an Assistant District Attorney for New York County under Robert M. Morgenthau, where his assignments included prosecuting homicide cases in the Homicide Bureau. Mr. McNamara served for five terms as a member of the New Jersey Supreme Court Committee on Model Criminal Jury Charges, and is a member of the New Jersey Supreme Court Criminal Practice Committee. He holds a B.A. and M.A. in History from the University of Scranton, a J.D. from the Catholic University of America Columbus School of Law, and served as a judicial clerk to the Hon. Donald G. Collester, Jr., J.A.D.
