Program Summary

Daniel's Law is a New Jersey statute that protects the personal information of active or retired judges, prosecutors, law enforcement officers, and their immediate family members. Government agencies, individuals, and businesses are prohibited from publishing the home addresses and telephone numbers of individuals who request protection under Daniel's Law. This program will provide prosecutors with an overview of Daniel's Law. The presenters will discuss covered persons and the registration process, redactors and their appointment, qualifications, roles and responsibilities, the redaction request workflow, and future portal updates.

Eligibility

This program is open to County Prosecutors and Assistant Prosecutors, Deputy Attorneys General in the Department of Law and Public Safety's Division of Criminal Justice and law enforcement officers in their respective offices.

Faculty

Christine Campbell is the Director of the New Jersey Department of Community Affairs Office of Information Privacy. The office was established to carry out the mandates of Daniel's Law. Previously, Ms. Campbell was the Deputy Chief Technology Officer for Legal and Compliance at the New Jersey Office of Information Technology (NJOIT). She provided oversight and guidance

for the staff on legal matters, acted as a liaison between NJOIT and the Attorney General's Office, and worked with the policy unit to review, update, and prepare policies and procedures for NJOIT's business operations. She also served as a special assistant to the Deputy State Treasurer at the NJ Department of the Treasury and as an assistant prosecutor in Camden County. Ms. Campbell was a law clerk for the Presiding Judge, Criminal Division in Camden County. She earned a B.A. in English from St. Joseph's University and a J.D. from Temple University.

Robert A Feher is the regulatory officer in the New Jersey Department of Community Affairs' Office of Information Privacy. The office is charged with implementing Daniel's Law, which prohibits disclosure of certain information with respect to specific public officials, as well as disclosure of certain information about their immediate family members residing in the same household with them, on New Jersey State, county, and municipal government websites. He previously served as a regulatory officer in the Department's Division of Housing and Community Resources. Mr. Feher earned a B.A. in English from Rollins College in Winter Park, Maryland and a J.D. from the University of Baltimore School of Law in Baltimore, Maryland.

Joshua M. Ottenberg is the Director of the County/State Agency Division of CSI Technology Group, where he is the vice president in charge of county and state level projects. Mr. Ottenberg played a key role in developing and implementing the eDiscovery Portal project in sixteen counties and the Attorney General's Office, and helped to develop and implement electronic Case Screening based on the ECDR feed from the New Jersey Administrative Office of the Courts. Prior to joining the CSI group, Mr. Ottenberg served in the Camden County Prosecutor's Office as Acting Prosecutor, First Assistant Prosecutor, Deputy First Assistant Prosecutor, Section Chief of the Homicide Unit, Police Legal Advisor, and Section Chief of the Major Crimes Unit. He holds Bachelor's and Master's Degrees from the University of Chicago and a J.D. from the University of the Pacific McGeorge School of Law in Sacramento, California.

John Porter is the Deputy Director of the County/State Agency Division of CSI Technology Group. He designs customizable eGovernment software for criminal justice, intelligence, prosecutorial, and judicial domains. Prior to joining CSI Technology Group, Mr. Porter was the Chief Investigator at the Gloucester County Prosecutor's Office. He began his career as a police officer with the Deptford Township Police Department. Mr. Porter earned a B.A. from Farleigh Dickinson University.
