# **Bankruptcy 201: Advanced Bankruptcy Concepts**

#### **Program Summary**

This program covers advanced concepts in bankruptcy law. Attendees should have a basic familiarity with fundamental bankruptcy concepts, including petitions under Chapters 7, 11, and 13 of the Bankruptcy Code, the automatic stay, and proofs of claim. The presenter will provide practical guidance for understanding and handling bankruptcy matters under Chapters 7, 11, and 13. She will discuss bankruptcy court powers and explain the roles of key players in the bankruptcy process. The presenter will also highlight key events in bankruptcy cases, including meetings of creditors, bar dates for filing proofs of claim, plan confirmation under Chapters 11 and 13, and bankruptcy appeals.

### Eligibility

This program is open to attorneys in the Department of Law and Public Safety and county prosecutors' offices. Registrants will receive the course materials prior to the program date.

#### Faculty

She is a past Chair of the Bankruptcy Law Section of the New Jersey State Bar Association and a Master in the Bankruptcy American Inn of Court of New Jersey. In recognition of her expertise, leadership, and service to the bankruptcy community, DAG Hamilton will be inducted as a Fellow of the American College of Bankruptcy in March 2024.
