Program Summary

This program will present a review of significant opinions from the New Jersey Supreme Court and Appellate Division during the 2023 -2024 court term.

Eligibility

This program is designed for attorneys in the Division of Criminal Justice and county prosecutors' offices. However, it is open to all deputy and assistant attorneys general in the Department of Law and Public Safety.

Faculty

DAG Thomas Caroccia serves in the Division of Criminal Justice's Appellate Bureau, where he handles criminal appeals in the Appellate Division and Supreme Court of New Jersey. identification, the Second Amendment, and Miranda Warnings. DAG Schwartz also teaches courses on criminal law to law enforcement officers and prosecutors. Prior to joining the Division, DAG Schwartz clerked for the Honorable Patrick DeAlmeida, J.A.D., while he was the Presiding Judge of the Tax Court and a judge in the Appellate Division. She received a B.A. from the College of Staten Island and a J.D., *cum laude* from Seton Hall Law.

DAG Laura Wojcik serves in the Division of Criminal Justice's Appellate Bureau, where she briefs and argues criminal appeals. Prior to joining the Division, DAG Wojcik clerked for the Honorable Ronald Susswein, J.A.D. She received a B.A., *magna cum laude*, from Colgate University, and a J.D., *cum laude*, from Temple University Beasley School of Law.
