Program Summary

This presentation will provide students with an overview of the most common objections that can be made at trial.

Eligibility

This program is mandatory for new assistant prosecutors and Division of Criminal Justice deputies hired after October 2023 who have been selected to attend by each county prosecutor's office and the Division of Criminal Justice. Other assistant prosecutors and deputy and assistant attorneys general in the Divisions of Criminal Justice and Law are also welcome to register.

Faculty

DAG John Nicodemo is on a mobility assignment with the Division of Highway Traffic Safety. He assists with implementing a community engagement initiative that is required under all federally funded highway traffic safety programs. He also serves as a hearing officer for the OAG Disciplinary Review Board. Before that, DAG Nicodemo was Deputy Chief of the Public Corruption Bureau in the Office of Public Integrity and Accountability. He also served as a member of the criminal working group for the Attorney General's Reproductive Rights Strike Force. DAG Nicodemo began his career in DCJ as a prosecutor in the Financial, Cyber and Public Corruption Bureaus. After earning a Bachelor's Degree and an M.B.A. from Temple University, DAG Nicodemo worked in the entertainment industry. He subsequently earned a law degree from Touro College Jacob D. Fuchsberg Law School in New York.
