## **WEBINAR**

### ***Program Summary***

The State of New Jersey is invested in helping individuals with criminal contacts within the State to advance their personal and professional lives. In the last ten years, the Legislature has implemented this goal by substantially expanding expungement relief, most recently amending Chapter 52 of Title 2C in January 2024. With the dynamic nature of the statute and the introduction of the eCourts Expungement Module in late 2020, it is essential for assistant prosecutors and DAsG to keep abreast of changes in this important area of the law.

This program will build on the previous Expungement Basics CLE by focusing on Regular & Clean Slate Expungements: who is eligible, when they are eligible, and what convictions make an individual ineligible for expungement relief. The presenter will provide additional details on expedited expungements and discuss in more depth the January 2024 changes to the statute, pending legislation, and recent decisions affecting expungement. This program is designed to equip assistant prosecutors and deputy attorneys general with the knowledge they need to assist with long-term considerations in prosecuting and resolving cases.

### ***Eligibility***

This program is open to County Prosecutors and Assistant Prosecutors, Assistant and Deputy Attorneys General in the Department of Law and Public Safety's Division of Criminal Justice, and law enforcement officers in their respective offices.

### ***Faculty***

**Assistant Prosecutor Elizabeth L. Doyle** is a member of the Camden County Prosecutor's Office. She is the Deputy Section Chief of the Civil Litigation and Records Management Unit, where her duties include working with expungements. She is also an instructor at the Camden County Police Academy. AP Doyle has also served in the Motions & Appeals, Juvenile, Trial Team, Grand Jury, Domestic Violence, and Special Victims Units. Prior to joining the CCPO, AP Doyle was briefly in private practice in a Philadelphia civil law firm. Before becoming a lawyer, she had a career in computer systems. AP Doyle clerked for the Honorable John Tomasello, J.S.C. (Retired/Recall) when he sat as the Presiding Judge of the Criminal Division for Gloucester/Cumberland/Salem Counties (Vicinage XV). She holds a B.S. in Biology from the University of Massachusetts at Amherst, an M.S. in Administration from Boston College, and a J.D. from Widener University Delaware School of Law.
