Program Summary

This program will explore the function and purpose of the New Jersey Election Law Enforcement Commission (ELEC), including an overview of the State's campaign finance laws and regulations. The presenters will detail the campaign finance reporting requirements for New Jersey candidates, political committees and lobbyists and explain how ELEC exercises its enforcement powers. The presenters will also highlight the newly adopted Election Transparency Act and describe the State's unique public financing program.

Eligibility

This program is open to attorneys in the Department of Law and Public Safety and county prosecutors' offices.

Faculty

Aurea Vazquez-Alexander manages ELEC's Compliance program, including the processing, review, and disclosure of reports filed by regulated entities, such as candidates, committees, governmental affairs agents, represented entities, business entities contracting with the State, and professional campaign fundraisers. She also administers the Gubernatorial Public Financing Program, directs the training of participating candidates and campaigns, and interprets statutory and regulatory requirements for participants, treasurers, and legal counsel. Additionally, she is the Commission's Open Public Records Act Custodian. Ms. Vazquez-Alexander spent over 15 years in legal and compliance leadership roles at several Fortune 500 companies. She has also served in all three branches of State government, as Counsel to three New Jersey Governors, Counsel for the New Jersey Senate, and Staff Counsel in the New Jersey Administrative Office of the Courts. Ms. Vazquez-Alexander received a Bachelor of Arts degree from Boston College and a Juris Doctor from Suffolk University School of Law.

Scott Miccio is the Deputy Legal Director for the New Jersey Election Law Enforcement Commission. He prosecutes alleged violators of State campaign finance laws and assists with oversight of the Commission's Review & Investigations Department. He has spent his legal career representing New Jersey municipalities and State agencies in both a private and public capacity. Mr. Miccio received a B.A. in Professional Writing from The College of New Jersey and a J.D. from Rutgers University.
