#### *Program Summary*

What should you and your client consider before hitting "send" or more importantly "reply all?" Is that email privileged? Will your adversary see it? Will the public see it? Does the recipient understand that simply forwarding the email could waive attorney-client privilege not only for this email, but for the entire chain? Learn about what should or should not be in an email and the RPC implications of this indispensable tool.

#### *Faculty*

**Brian Lipman** is the Director for the Division of Rate Counsel, which represents the interests of regulated utilities consumers. Mr. Lipman currently serves as the president of the Consumer Advocates of PJM States. He was previously the Division's Litigation Manager. Prior to joining the Division of Rate Counsel, Mr. Lipman was a Deputy Attorney General in the Division of Law. He last served as the Assistant Section Chief for the Public Utilities Section, where he was involved in a variety of federal energy matters before the Federal Energy Regulatory Commission and the U.S. District Court and advised the Board of Public Utilities. Mr. Lipman also served as a DAG in the Affirmative Litigation Section, working on mortgage fraud matters and other cases for a number of administrative agencies, including the Election Law Enforcement Commission. He additionally served as legal counsel to the Division on Civil Rights, prosecuting cases on behalf

of the Division. Before commencing State service, Mr. Lipman represented private employers in employment litigation matters as an associate with the firms of Carpenter, Bennett & Morrissey and Genova, Burns & Vernoia. Mr. Lipman also represented federal employees in employment litigation as an associate at Schnieder, Frieberger & Kastner. Mr. Lipman holds a B.S. in political science from The American University. He graduated with honors from Rutgers School of Law-Camden, where he received the Arthur T. Vanderbilt award for Legal History. He clerked at the Monmouth County Prosecutor's Office and was a pupil in the Sidney Reitman Inns of Court.
