The Division of Criminal Justice Academy has been a Police Training Commission approved academy since 1980. Originally established to conduct the Basic Course for Investigators, the Division of Criminal Justice Academy has expanded its curriculum to include other PTC approved courses, such as the revised Modified Basic Course for Investigators, as well as diverse Firearms Instructor level courses and Basic Arson Investigator through the Middlesex County Fire Academy. In addition, the Academy conducts a wide variety of specialty and management development courses not generally available at other police academies. The Academy also provides continuing education to state investigators and deputy attorney generals from the Division of Criminal Justice.

**BASIC COURSE FOR ARSON INVESTIGATORS (BCAI) \$1,000.00 \*FEE CHANGE PER PERSON\***

This course is mandated pursuant to N.J.S.A. 40A: 14-7.1 for fire personnel assigned to certified arson investigation units in municipal fire departments. Program topics include the investigation and prosecution of arson, the cause and origin of fire, interview and interrogation techniques, profile of an arsonist, the New Jersey Code of Criminal Justice, and motives for arson. Classroom instruction is supplemented by a practical exercise involving the investigation of actual fire scenes. ***Applications Approval by your County Prosecutor's Office is required. Class size is limited to 40.***

**Who Should Attend:**

- *Paid firefighters assigned to a certified municipal arson investigation unit;*
- ***Paid fire personnel assigned to a county arson investigation unit;***
- *Police officers, County Prosecutor's Office investigators or detectives, and Assistant Prosecutor's assigned to investigate arson.*
- **NOTE:** *Prior to the start of the BCAI class, the student will have completed the following from CFITrainer.net:*
  - ***The Scientific Method for Fire and Explosion Investigation – 3 hours***
  - ***Fire Investigator Scene Safety – 3 hours***
  - ***Basic Electricity – 4 hours***
  - ***Documenting the Event – 4 hours***
  - ***Ethics and the Fire Investigator – 3 hours***
  - ***Arc Mapping – 4 hours***

CFITrainer.net is free and will be referred to throughout the class. It can be found online at <http://cfitrainer.net>. You must register to be able to complete the assignments and will receive a transcript of the training completed. Once registered, the site allows you to proceed at your own pace. **Transcripts will be collected on the FIRST DAY OF CLASS.**

## ARSON INVESTIGATION IN-SERVICE – TBD

This course, mandated pursuant to N.J.S.A. 40a: 14-7.1 for fire personnel assigned to certified arson investigation units in municipal fire departments, is a continuation of the Basic Arson Investigation training and is required for arson investigators appointed pursuant to this statute. The in-service training specializes in more advanced aspects of arson investigation and prosecution.

**Who Should Attend:** Attendance is *strictly* limited to those personnel assigned to certified arson investigation units in municipal fire departments created by municipal ordinance. *Invitation only class.*

## BASIC COURSE FOR INVESTIGATORS (BCI)

This basic training program covers general topics such as investigative procedures essential to the successful investigation, apprehension, and prosecution of criminals. In accordance with the provisions of the Police Training Act, this course is mandatory for county prosecutor's investigators and detectives, state investigators, and arson investigators who are assigned to certified arson investigation units. Some components of this course include: Basic Firearms training, Defensive Tactics and Physical Conditioning training.

**Who Should Attend:** County prosecutor's investigators and state investigators with no prior basic law enforcement training in New Jersey and arson investigators assigned to certified arson investigation units.

**Requirements:** Drug screening results submitted by sending agency prior to Orientation date and medical certification.

## Firearms Instructor Course

**Cost: \$400**

**Dates: April 7 – 11, 2024 (Days 1-3, and Day 5 are 0800-1600, Day 4 is 1200-2200 for night fire)**

**Location: Jackson Township Police Range, 704 Dorathys Lane, Jackson NJ, 08527**

**Pre-Requisites:** Students must pass 3 consecutive runs of the HQC-1 (60 round course) on Day 1 with an average of 95% (57/60) and score an 80% (48/60) on the HNQC on Day 4. Students must arrive with an above average shooting ability and poor shooters should not attend. Additionally, students are required to safely handle their weapons throughout the course. Safety violations may result in immediate expulsion from the program and agency notification. **\*\*\*STUDENTS ARRIVING WITH HANDGUNS EQUIPPED WITH RED DOT SIGHTS MUST SHOOT ALL QUALIFICATIONS WITH THE BACKUP IRON SIGHTS ON THEIR HANDGUN WITHOUT THE USE OF THE OPTIC\*\*\***

### **Description:**

**\*\*\*THIS IS A POLICE TRAINING COMMISSION CERTIFIED COURSE\*\*\***

The Firearms Instructor Course is a 5-day, 40-hour program designed to provide agencies with an instructor capable of conducting the required semi-annual firearms qualifications for the handgun and shotgun (if issued/authorized), provide marksmanship instruction, and be able to coach, diagnose, and fix struggling shooters. Graduates will be able to safely conduct firearms training, run their ranges, and keep detailed records as required by the Attorney General guidelines. Additionally, a review of the AG guidelines pertaining to firearms will be conducted. Attendees will learn the roles and responsibilities of a firearms instructor, as well as safety related to firearms, classroom sessions, and range operations. Issues such as legal and liability topics will be covered, the proper student to instructor ratio per weapon, and how to teach marksmanship skills. Students will also be taught how to run the line as an instructor safely and give appropriate range commands.

The student will be shown methods conducive to maximizing student retention of the material, develop and evaluate drills and training packages, and will have an opportunity to put their skills to the test using the other students as simulated trainees during the program. Students will be subject to spot checks such as spontaneous teaching assignments and presentations throughout the course to ensure retention of the material at an instructor level.

As this is an instructor-level course, **it is performance based**. Mere registration and attendance does not guarantee graduation or a course certificate. There will be a pre-qualification conducted on day 1 to gauge the student's current ability to effectively employ the handgun and safely manipulate it. Students will be required to pass graded teach-backs of selected topics, range presentations, training development and delivery, as well as a written exam to ensure retention of material presented throughout the program. Failure to pass any of the required testing will result in the student not being awarded an instructor certification. This is not a gentleman's course and students who arrive without above average shooting skills may not pass the program.

**\*\*\*HANDGUNS EQUIPPED WITH RED DOT SIGHTS (RDS) ARE BECOMING MORE COMMON IN NEW JERSEY LAW ENFORCEMENT WITH MANY AGENCIES ISSUING OR APPROVING THESE WEAPONS FOR DUTY USE. IF AN AGENCY ISSUES OR APPROVES HANDGUN RDS ON THEIR DUTY WEAPON, STUDENTS CAN BRING THEIR AGENCY ISSUED OR APPROVED DUTY HANDGUN EQUIPPED WITH AN RDS SIGHTING SYSTEM TO THE COURSE.**

**HOWEVER, THE PRE-QUALIFICATION MUST BE SHOT WITH THE BACKUP IRON SIGHTS ON THE HANDGUN. ADDITIONALLY, THE HANDGUN NIGHT QUALIFICATION MUST BE SHOT WITH THE BACKUP IRON SIGHTS.**

**HANDGUNS EQUIPPED WITH RDS SIGHTING SYSTEMS WITHOUT BACKUP IRON SIGHTS THAT CAN BE CO-WITNESSED THROUGH THE OPTIC ARE PROHIBITED. THE MERE PRESENCE OF IRON SIGHTS ON THE SLIDE WILL NOT SUFFICE UNLESS THEY ARE HIGH ENOUGH TO BE SEEN THROUGH THE OPTIC WINDOW. STUDENTS ARRIVING WITH NON-**

**COMPLIANT HANDGUNS WILL BE PROHIBITED FROM SHOOTING THE PRE-QUALIFICATION WITH THAT WEAPON SINCE IRON SIGHTS WILL NOT BE VISIBLE.**

**AFTER PASSING PRE-QUALIFICATION WITH THE IRON SIGHTS, STUDENTS MAY CONTINUE TO USE THE RDS THE REST OF THE WEEK WITH THE EXCEPTION OF THE HANDGUN NIGHT QUALIFICATION.**

**STUDENTS ARRIVING WITH AN RDS EQUIPPED HANDGUN MUST HAVE THE RDS ZEROED (EITHER A 10/15/25 YARD ZERO) PRIOR TO DAY 1 AS THERE WILL BE NO TIME ALLOTTED FOR ZEROING.**

**THE FIREARMS INSTRUCTOR COURSE WILL NOT PROVIDE INSTRUCTION OR CERTIFICATION ON HANDGUN RDS EMPLOYMENT. STUDENTS ARRIVING WITH A HANDGUN EQUIPPED WITH RDS WILL BE EXPECTED TO HAVE APPROPRIATE TRAINING ON THE SYSTEM AND HAVE THE OPTIC INSTALLED CORRECTLY. THE STUDENT IS RESPONSIBLE FOR REPAIRS OF ANY FAILURES OF THEIR RDS SYSTEM.**

**AGENCIES ARE ENCOURAGED TO SEEK OUT REPUTABLE INSTRUCTOR LEVEL TRAINING PRIOR TO AUTHORIZING AND FIELDING HANDGUN RDS SYSTEMS. THE POLICE TRAINING COMMISSION AND DIVISION OF CRIMINAL JUSTICE DO NOT ENDORSE OR RECOMMEND ANY SPECIFIC THIRD-PARTY ENTITY AND AGENCIES ARE ADVISED TO DO THEIR OWN DUE DILIGENCE ON ANY TRAINING PROVIDER BEING CONSIDERED FOR HANDGUN RDS TRAINING\*\*\***

#### **Individual Equipment Requirements:**

**\*\*\*STUDENTS WHOSE AGENCIES DO NOT ISSUE/AUTHORIZE SHOTGUNS ARE NOT REQUIRED TO BRING SHOTGUNS OR SHOTGUN AMMUNITION TO THE COURSE\*\*\***

**MODIFIED BASIC COURSE FOR INVESTIGATORS (MBCI) COST: \$100.00 \*FEE CHANGE PER CLASS\***

Effective June 1997, the PTC replaced the *Modified Basic Course for Investigators (MBCI)* with a requirement that newly-hired county prosecutor's investigators and detectives, with previous law enforcement experience and training, must complete. A core in-service training curriculum consists of the following courses: **Criminal Procedure Update, Internal Affairs Policy and Procedure, Interview & Interrogation, and Investigator Safety and Security.** These four classes are NOT open to any other Law Enforcement personnel. Information concerning each of these specific courses is provided below.

These courses will be offered on four consecutive days in both the spring and fall. You **must** choose either the spring or fall courses and complete same within the four day block. You **cannot** split the classes between spring and fall. Few exceptions for splitting the classes may be considered by providing written request to the PTC, with valid reason, and the PTC having granted your request PRIOR to the class start date.

You are required to advise the PTC of your new hire prior to registering a candidate.

## Patrol Rifle Instructor – *Class size is limited to 12*

Cost: **\$400**

Dates: April 28 – May 2, 2025 (Days 1-3, and Day 5 are 0800-1600, Day 4 is 1200-2200 for night fire)

Location: NJ Fish and Game Training Center, 401 Hawkin Road, Jackson Township, Jackson NJ, 08527

**Pre-Requisites:** Students **must** have previous training and experience with the patrol rifle prior to class. Students must be able to safely load, unload, and clear all malfunctions with their rifle, as well as know how to zero their sighting systems. **THIS IS NOT A BASIC PATROL RIFLE OPERATOR COURSE.** Basic Instructor certifications such as Methods of Instruction are highly recommended prior to class but not mandatory. There is no time during class for basic “presentation skills” training such as PowerPoint so students should plan accordingly. Students should have training experience or aspire to a trainer billet within their agency/unit. Previous attendance at a Firearms Instructor Course is required, as well as proof of formal end-user level training on the Patrol Rifle. Proof may come in the form of a formal course certificate from a patrol rifle training program, or certification from the student’s agency /Supervising Firearms Instructor that the attending officer possesses the appropriate level of training for the class.

**Description:** The Patrol Rifle Instructor course is a 5-day, 40-hour program meant to provide units and agencies with an instructor capable of delivering training in the basics of patrol rifle operations at a level appropriate for new or inexperienced personnel, as well as implement a patrol rifle training program or improve an existing one. The class provides for a **review** of foundational patrol rifle techniques and concepts but is not designed to be the student’s first exposure to the patrol rifle. The emphasis will be on **how to teach** the concepts taught and implement them at the agency level. The student will be shown methods conducive to maximizing student retention of the material, develop and evaluate drills and training packages, and will have an opportunity to put their skills to the test using the other students as simulated trainees during the program. Students will be subject to spot checks such as spontaneous teaching assignments and presentations throughout the course to ensure retention of the material at an instructor level.

As this is an instructor-level course, **it is performance based.** Mere registration and attendance does not guarantee graduation or a course certificate. There will be a diagnostic conducted on day 1 to gauge the student’s current comprehension of patrol rifle operations and their ability to effectively employ the weapon and safely manipulate it. Students will be required to pass graded teach-backs of selected topics, range presentations, training development and delivery, as well as a written exam to ensure retention of material presented throughout the program. Failure to pass any of the required testing will result in the student not being awarded an instructor certification. This is not a gentleman’s course and students must arrive with foundational end-user level training in the patrol rifle and students who arrive without above average patrol rifle skills may not pass the program.

Take the Garden State Parkway South to Exit 98 (Highway 34 South). Go through the traffic light to the circle and proceed as if going straight up the hill. A Honda dealership and lumber yard will be on your right.

Go to the first turn off. You will see a highway sign which says Sea Girt, Manasquan. Take this ramp around to the right. This will take you under Hwy. 34 and onto Atlantic Avenue. A fire house and industrial park will be on your right. Travel along this road about a mile or so. Just after passing a shopping mall on the right and a farm market on the left, you will be at the Manasquan Circle. Continue 3/4 of the way around the circle onto Hwy. 35 North. Make a right turn at the first traffic light onto Sea Girt Avenue. There will be a Kentucky Fried Chicken and Foodtown store on the right.

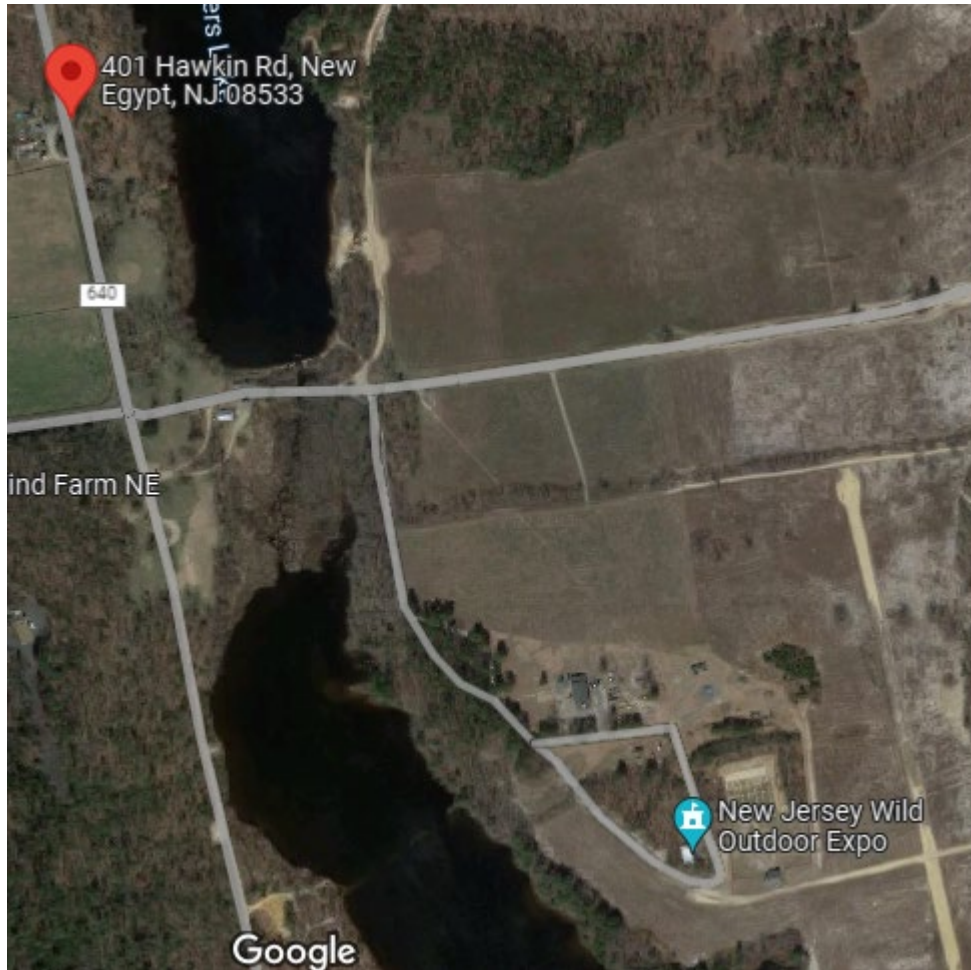

Turn off at Bonhamtown Exit to County Road 531 (Main Street) and proceed to traffic light. Turn right (just before light) onto County Road 514 West (Woodbridge Avenue). Proceed to third traffic light and turn left onto County Road 667 (Mill Road). Go past traffic light (College Ave.) to next sharp left turn (90 degrees); at sign for Thomas Edison Park make left. Go over railroad tracks (100 yards). Make immediate left turn to Police Training Center.

#### GARDEN STATE PARKWAY NORTH

Turn off at Exit 127 and follow the signs to Interstate 287 and then the signs to 514 West, Bonhamtown (Woodbridge Avenue). When on 514 West, turn left at the sixth traffic light onto County Road 667 (Mill Road). Go past traffic light (College Ave.) to next sharp left turn (90 degrees); at sign for Thomas Edison Park make left. Go over railroad tracks (100 yards). Make immediate left turn to Police Training Center.

#### GARDEN STATE PARKWAY SOUTH

Turn off Exit 130 to U.S. Highway 1 South. Take Bonhamtown Exit off Route 1 to County Road 531 (Main Street). Proceed down Main Street and turn right (just before light) onto County Road 514 West (Woodbridge Avenue). Proceed to third traffic light and turn left onto County Road 667 (Mill Road). Go past traffic light (College Ave.) to next sharp left turn (90 degrees); at sign for Thomas Edison Park make left. Go over railroad tracks (100 yards). ### FROM GARDEN STATE PARKWAY SOUTH BOUND

Get off the Parkway at Exit 135 and stay to the right while going down the ramp. This will be Central Avenue. Make a left at the first light (White Diamonds on the corner) onto Raritan Road.

After the third light on Raritan Road there will be a school, Hehnlly Grammar School. Bear right when passing the school. At the next light make a right onto Lake Avenue (Routondo Liquor Store will be on the left). Continue over the bridge, stay to the left and approximately .5 miles down Raritan, on the left, is the Union County Vocational/Technical School. Enter the driveway and bear right. The Academy is located in the back of the campus parking lot. You will also notice blue and white *John H. Stamler Police Academy* signs along the above route.

### FROM GARDEN STATE PARKWAY NORTH BOUND

Get off the Parkway at Exit 135, bear left down the ramp. Continue through the circle and go underneath the Parkway bridge heading straight onto Central Avenue. Make a left at the first light onto Raritan Rd. At this point, follow the above directions.

### FROM ROUTE #22 EAST OR WEST
