DGE Announces February 2021 Total Gaming Revenue Results

Industry:

Based upon filings with the Division of Gaming Enforcement, Total Gaming Revenue for February was \$288.3 million compared to \$287.3 million in February 2020, reflecting a 0.3% increase. Internet Gaming Win was \$93.8 million in February compared to \$52.0 million in the prior period, reflecting an increase of 80.4%. Sports Wagering Gross Revenue was \$46.2 million for the month. Casino Win for February was \$148.2 million, decreasing 32.1% from the same month last year. During February, the casinos operated with certain restrictions due to COVID-19.

For the first two months, the Industry's Total Gaming Revenue was \$634.4 million compared to \$587.8 million, reflecting an increase of 7.9%. Casino Win was 308.3 million reflecting a 24.8% decrease over the prior period. Internet Gaming Win increased 84.5% to \$197.6 million when compared to the prior period. Sports Wagering Gross Revenue was \$128.6 million.

Tax Information:

For the month of February 2021, total gaming taxes were \$30.2 million. Total gaming taxes reflect 8% of taxable casino gross revenue, 15% of Internet gaming gross revenue, 8.5% tax on casino and racetrack sports wagering gross revenue and 13% tax on casino and racetrack sports wagering Internet gross revenue. In addition, the casino industry incurred \$4.4 million in 1.25% Additional Tax on sports wagering gross revenue and Investment Alternative Tax Obligations (which reflects 1.25% of casino gross revenue and 2.5% of Internet gaming gross revenue). For the month of February 2021, the Racetrack Economic Development Tax of 1.25% of racetrack sports wagering gross revenue was \$361,392.

- Total Gaming Revenue consists of Casino Win, Internet Gaming Win and Sports Wagering Gross Revenue. Sports wagering statistical information is unaudited and subject to adjustment. The statistical completed events Win and Handle information is provided by each casino/racetrack licensees' platforms operating under its sports wagering license.
