DGE Announces November 2024 Gaming Revenue Results

Casino Win:

Based upon filings with the Division of Gaming Enforcement, Casino Win for the nine casino hotel properties was \$223.9 million for November 2024, reflecting an increase of 4.2% when compared to \$214.9 million reported in November 2023. Year-to-date Casino Win for the nine casino hotel properties was \$2.59 billion, which is a decrease of 1.1% compared to the year-to-date Casino Win for November 2023. Internet Gaming Win:

For the month of November 2024, Internet Gaming Win reported by casinos and their partners was \$214.0 million, reflecting growth of 24.7% when compared to \$171.6 million reported in November 2023. For the year-to-date period, Internet Gaming Win reported by casinos and their partners was \$2.16 billion, reflecting growth of 23.8% when compared to \$1.74 billion for the prior year-to-date period. Sports Wagering Gross Revenue:

Sports Wagering Gross Revenue reported by casinos, racetracks, and their partners was \$119.0 million for November 2024, reflecting a 24.1% increase when compared to \$95.9 million reported in November 2023. Sports Wagering Gross Revenue reported by casinos, racetracks, and their partners was \$1.03 billion for the year-to-date period, reflecting a 15.0% increase when compared to \$897.2 million reported in the prior year-to-date period. Total Gaming Revenue:

Total Gaming Revenue reported by casinos, racetracks, and their partners was \$556.9 million for November 2024, reflecting a 15.4% increase from \$482.4 million reported in November 2023. For year-to-date, Total Gaming Revenue reported by casinos, racetracks, and their partners was \$5.78 billion, reflecting a 9.9% increase from \$5.26 billion reported in the prior year-to-date period.
