## **DGE Announces Quarterly and Year-To-Date Results**

### Casino Net Revenue and Gross Operating Profit

Based upon filings made with the Division of Gaming Enforcement, the casino licensees reported 2<sup>nd</sup> quarter 2021 Net Revenue of \$726.5 million and a Gross Operating Profit of \$185.2 million. For the first six months of 2021, Net Revenue was \$1.3 billion and the Gross Operating Profit was \$280.6 million. In light of the casino hotel closures beginning March 16, 2020 through July 2, 2020 due to the COVID-19 pandemic, the Net Revenue and Gross Operating Profit for the 2<sup>nd</sup> guarter and year-to-date are not comparable to the 2020 period.

### **Hotel Occupancy:**

The occupancy rate in the industry's casino hotels for the three months ended June 2021 was 70.0% and the occupancy rate for the six months ended June 2021 was 61.2%. There are no comparable hotel occupancy statistics for the 2020 period due to the casino hotel closures.

The following notes are integral to understanding the financial information contained in this press release. The notes provide a description and source of the data.

#### Notes:

- <u>Net Revenue</u> is the amount reported on Line 5 of the income statement. Net Revenue reflects Casino Revenue (less all promotional allowances) plus Rooms Revenue, Food and Beverage Revenue and Other Revenue as reflected on each casino licensees' income statement.
- Gross Operating Profit reflects earnings before interest, taxes, depreciation, amortization, charges from affiliates, and
  other miscellaneous items as reflected on each casino licensees' income statement. It is a widely-accepted measure of
  profitability in the Atlantic City gaming industry.
- Average Rate Per Occupied Room reflects Rooms Revenue as reported on the casino licensees' Statements of Income
  (which includes the value of complimentary rooms) divided by the number of occupied room nights for the period.
- The footnotes are an integral part of each casino licensee's financial statements. Valid comparisons cannot be made without using the information contained in the footnotes.
