Audit Committee Charter and Members

WHEREAS, on March 30, 2015, casino licensee Trump Taj Mahal Associates, LLC (TTMA), d/b/a Trump Taj Mahal Casino Resort (Trump Taj Mahal) filed PRN 0891501 seeking declaratory rulings regarding entity and natural person qualifiers of TTMA and other relief in connection with the anticipated Effective Date of the Third Amended Joint Plan of Reorganization of TTMA and its holding and affiliated companies (Plan) and the associated ownership change which will result from consummation of the Plan (the Restructuring); and

WHEREAS, as part of its requests for other relief, TTMA seeks determinations by the Division of Gaming Enforcement (Division) that: (1) following the Restructuring, continued use of the existing audit committee charter for Trump Entertainment Resorts, Inc. (TER), as amended and restated as of July 30, 2010, is acceptable; (2) nothing in that audit committee charter violates provisions of the Casino Control Act (Act); and (3) the proposed three new members of the TER audit committee, namely, Jack G. Wasserman, Denise Barton, and Peter Shea are independent and meet all regulatory requirements; and WHEREAS, pursuant to Resolution No. 10-11-10-21 granting a plenary casino

license to Tropicana Atlantic City Corp., Jack G. Wasserman is currently qualified and

there is no information indicating that he is not independent; it is hereby

**ORDERED**, that pursuant to *N.J.A.C.* 13:69D-1.11(c), there is nothing contained in

the previously-reviewed July 30, 2010 TER audit committee charter which violates the Act

or any pertinent regulation thereunder, and such charter may continue to be utilized for a

90-day period following the Restructuring; and it is further

**ORDERED**, that within 90 days of the Effective Date of the Plan, TTMA shall: (1)

conduct a critical review of the July 30, 2010 TER audit committee charter to determine if

any updates, amendments or other changes are appropriate; and (2) submit a current and

revised, as applicable, audit committee charter to the Division for its review and approval;

and it is further

ORDERED, that because Jack G. Wasserman is currently qualified and the

Division's previously-completed background investigation reveals no information which

raises concerns regarding his independence, he is authorized to serve as a member of the

TER audit committee; and it is further

**ORDERED**, that the Division's position concerning the individual qualifications and

the independence of Denise Barton and Peter Shea will be addressed in separate reports

which will be issued to the Commission in connection with the Restructuring.
