WHEREAS, on or about November 20, 2018, the Division of Gaming Enforcement ("Division") served upon DGMB Casino L.L.C., D/B/A Resorts Casino Hotel ("Resorts"), a Notice of Violation, pursuant to N.J.A.C. 13:69B-2.9;

WHEREAS, the Division, via the above mentioned Notice of Violation, determined that Resorts shall be assessed a civil penalty in the amount of \$2,000 to address the late September 2018<sup>a</sup>, regulatory violations whereby Resorts allowed illegal wagers to be placed on prohibited sports events, specifically the Rutgers Scarlett Knights versus Indiana Hoosiers College Football Game and Columbia Lions versus Princeton Tigers College Football Game in violation of N.J.A.C. 13:69N-1.1;

WHEREAS, on or about December 12, 2018, Resorts acknowledged the violation and agreed with the Division's civil penalty determination in the amount of \$2,000;

Having considered the relevant provisions of the Casino Control Act, <u>N.J.S.A.</u> 5:12-1 <u>et seq.</u>, and the regulations promulgated thereunder, specifically <u>N.J.A.C.</u> 13:69B-2.9 <u>et seq</u>:

I HEREBY ORDER approval of the Notice of Violation and impose a civil penalty in the amount of \$2,000 upon DGMB Casino L.L.C., D/B/A Resorts Casino Hotel. This amount shall be payable, in full, by Resorts, upon filing of this order.
