WHEREAS, on or about February 7, 2019, the Division of Gaming Enforcement ("Division") served upon Boardwalk 1000, L.L.C., D/B/A Hard Rock Hotel & Casino Atlantic City ("Hard Rock"), a Notice of Violation, pursuant to N.J.A.C. 13:69B-2.9;

WHEREAS, the Division, via the above mentioned Notice of Violation, determined that the Hard Rock shall be assessed a civil penalty in the amount of \$1,000 to address the November 4, 2018, regulatory violations pertaining to Hard Rock's failure to detect an underage patron in violation of N.J.A.C. 13:69C-1.16.1(a), N.J.A.C. 13:69D-1.11(b)(1 and 6) and N.J.S.A. 5:12-119(a-b);

WHEREAS, on or about March 5, 2019, Hard Rock, acknowledged the violations and agreed with the Division's civil penalty determination in the amount of \$1,000;

Having considered the relevant provisions of the Casino Control Act, N.J.S.A. 5:12-1 et seq., and the regulations promulgated thereunder, specifically N.J.A.C. 13:69B-2.9 et seq.

I HEREBY ORDER approval of the Notice of Violation and impose a civil penalty in the amount of \$1,000 upon Boardwalk 1000, L.L.C., D/B/A Hard Rock Hotel & Casino

Atlantic City. This amount shall be payable, in full, by Hard Rock, upon filing of this order.
