As set forth by regulation, a pendent qualifier is required to establish his plenary qualification within 18 months.

The Division of Gaming Enforcement ("Division") has investigated his suitability for qualification and finds that he has established his good character, honesty, and integrity, as well as submitted the required financial information, pursuant to *N.J.S.A.* 5:12-92c(4), incorporated by reference in *N.J.S.A.* 5:12-92a(3), and should therefore be deemed to
