The Division of Gaming Enforcement (“Division”) having filed a complaint on February 11, 2020, seeking forfeiture, pursuant to *N.J.S.A. 5:12-71.3*, of \$11,843.81 in gaming winnings retained by HARRAH'S ATLANTIC CITY OPERATING COMPANY, LLC d/b/a HARRAH'S MARINA HOTEL AND CASINO (“Harrah’s”), which Harrah’s confiscated from SR, a self-excluded individual, who was prohibited from engaging in gaming activity pursuant to *N.J.A.C. 13:69G-2.1*; and

The complaint and notice of the right to demand a plenary hearing within fifteen (15) days pursuant to *N.J.S.A. 5:12-71.3* and *N.J.A.C. 13:69B-2.2a(4)* and -2.3(a), has been served upon Harrah’s and SR; and

Counsel for Harrah's having interposed no objection to the entry of a forfeiture order; and

SR, the self-excluded individual, failed to demand a plenary hearing thereby waiving her right to a hearing and constructively admitting the allegations in the complaint pursuant to *N.J.S.A. 5:12-71.3* and *N.J.A.C. 13:69B-2.4(a)2vi*; and

Having considered the entire record in this matter,

**IT IS ORDERED** that the amount of \$11,843.81 in gaming winnings owed to SR, a self-excluded individual, is hereby forfeited pursuant to *N.J.S.A. 5:12-71.3*; and

1. **IT IS FURTHER ORDERED** that HARRAH'S ATLANTIC CITY OPERATING COMPANY, LLC d/b/a HARRAH'S MARINA HOTEL AND CASINO is directed to remit the forfeited money to the Division of Gaming Enforcement upon receipt of an invoice from the Division's Revenue Unit for appropriate disposition in accordance with the terms of *N.J.S.A. 5:12-71.3c*.
