Dear Julia Simonsson:

In accordance with *N.J.A.C. 13:69J-1.14A* and *1.14B*, Julia Melanie Dorte Bettina Simonsson ("Julia Simonsson"), the Chief Legal Officer for Evolution Malta Limited, a casino service industry enterprise licensee, filed the appropriate qualifier forms and was designated a pendent qualifier of the entity. As set forth by regulation, a pendent qualifier is required to establish plenary qualification within 18 months.

The Division has investigated Julia Simonsson's suitability for qualification and finds that this pendant qualifier has established financial stability, integrity and responsibility, as well as good character, honesty and integrity, as is required by *N.J.S.A. 5:12-89b(1)* and (2), incorporated by reference in *N.J.S.A. 5:12-92b*, and should therefore be deemed to have established plenary qualification in connection with the casino service industry enterprise licensee.
