**IN THE MATTER OF A NOTICE OF
VIOLATION TO BOARDWALK REGENCY
CORPORATION D/B/A CAESARS
ATLANTIC CITY**

WHEREAS, on or about October 28, 2022, the Division of Gaming Enforcement (“Division”) served upon Boardwalk Regency Corporation D/B/A Caesars Atlantic City (“Caesars”), a Notice of Violation, pursuant to N.J.A.C. 13:69B-2.9;

WHEREAS, the Division, via the above-mentioned Notice of Violation, determined that Caesars shall be assessed a civil penalty in the amount of \$2,000 to address its failure to detect excluded individuals on August 14, 2021, November 11, 2021, and January 17, 2022, in violation of N.J.A.C. 13:69D-1.1, N.J.A.C. 13:69G-1.2(c), and N.J.A.C. 13:69G-1.7(a);

WHEREAS, the Division, via the above-mentioned Notice of Violation, also determined that Caesars shall be assessed a disgorgement in the amount of \$5,085 for funds Caesars failed to confiscate from an excluded patron;

WHEREAS, on or about November 28, 2022, Caesars acknowledged the violations and agreed with the Division’s civil penalty determination in the amount of \$2,000 and the disgorgement in the amount of \$5,085;

Having considered the relevant provisions of the Casino Control Act, N.J.S.A.

5:12-1 et seq., and the regulations promulgated thereunder, specifically N.J.A.C.
13:69B-2.9 et seq.:

I **HEREBY ORDER** approval of the Notice of Violation and impose a civil penalty in the amount of \$2,000 upon Boardwalk Regency Corporation D/B/A Caesars Atlantic City. This amount shall be payable, in full, by Caesars, upon filing of this order. Additionally, Caesars is **ORDERED** to disgorge the amount of \$5,085. This amount shall also be payable, in full, by Caesars, upon filing of this order.
