RE: Evolution Petition #2922201

Dear Lloyd Levenson,

The staff of the Division of Gaming Enforcement's (Division) Regulatory Enforcement Bureau has reviewed Petition #2922201 filed by Cooper Levenson on behalf of Evolution Malta Limited and Evolution US LLC, formerly Evolution New Jersey, LLC ("Evolution") on October 19, 2022. Specifically, the licensee is seeking to amend its current Operational Plan, approved under Petition #0842202 on March 29, 2022.

By Petition #2922201, Evolution seeks approval to complete modifications to its Live Casino Studio as depicted on the architectural drawings labeled I-OP-09 which was prepared and certified by Thomas J. Sykes, A.I.A., License #AI-00762900, of SOSH Architects on October 10, 2022, and released on October 13, 2022, by the Department of Community Affairs, Project Number AC-027-22 and incorporated herein by reference.



The petitioner proposes the following:

- 1. Rotate one (1) table in the internet studio.
- 2. Install one (1) access door to provide easier access for gaming personnel in the expanded studio.

Based on the Division's authority, the requested amendment to Evolution's Operational Plan, as set forth above, is hereby granted pursuant to N.J.A.C 13:69D-7.1 et seq.

This approval is subject to the following conditions:

- A. That Evolution complies with CCTV requirements identified in N.J.A.C. 13:69D-1.10 regarding the requirements to record all gaming tables whether active or inactive;
- B. That all CCTV cameras must be accessible from the Division's CCTV monitoring system as required by N.J.A.C. 13:69D-1.10(a)3;
- C. That Hard Rock Security Department is responsible for the security of the Evolution Live Studio; and
- D. Once modifications have been completed, satisfactory inspections and approvals by the Division are required to ensure that the changes made conform to the petition. The review also includes, but is not limited to, an assessment of the adequacy of CCTV and security coverage. Such inspections must be done prior to the proposed areas being used for gaming activity.
