The Division filed a complaint on or about June 20, 2023, under Docket Number 23-0787-VC that sought sanctions against PointsBet New Jersey LLC d/b/a PointsBet for violations of *N.J.A.C.* 13:69N-1.1 and *N.J.A.C.* 13:69N-1.11. More specifically, the Division sought sanctions against PointsBet for permitting wagering on a prohibited sporting event, the May 25, 2022 NCAA Basketball game involving St. Peter's University, a university located in New Jersey. The Division also sought sanctions against PointsBet for permitting wagering on an October 29, 2021 Electronic-Sports event "League of Legends World Championships", which involved an underage competitor, in violation of *N.J.A.C.* 13:69N-1.1 and *N.J.A.C.* 13:69N-1.11. Additionally, the Division sought sanctions against PointsBet for permitting wagering on an August 21, 2021 English Championship League soccer match, Cardiff City versus Milwall, after the outcome of the event was already known, in violation of *N.J.A.C.* 13:69N-1.9 and

N.J.A.C. 13:69D-2.3. PointsBet also permitted wagering on four other English

Championship League Soccer markets in August 2021, (A) Two separate markets

during Empoli versus Vicenza, (B) Sampdoria versus Alessandria, and (C) Dortmund

versus Bayern after the outcomes were already known; and

Having considered the relevant provisions of the Casino Control Act, N.J.S.A.

5:12-1 et seq., and the regulations promulgated thereunder, specifically, N.J.A.C.

13:69N-1.1, N.J.A.C. 13:69N-1.11, N.J.A.C. 13:69N-1.9, and N.J.A.C. 13:69D-2.3; and

Having considered the Stipulation of Settlement which the parties executed and

finding sufficient legal and factual support for the recommended penalty therein.

I hereby ORDER that the settlement be adopted and that a civil penalty in the

amount of \$25,000 be imposed upon PointsBet New Jersey LLC d/b/a PointsBet

payable upon receipt of an invoice from the Division.
