The Division of Gaming Enforcement (“Division”) filed a complaint on or about May 15, 2024 under Docket Number 24-0353-VC that sought sanctions against Sports Information Services Ltd. d/b/a Kambi (“Kambi”) and Rush Street Interactive NJ, LLC d/b/a Rush Street Interactive (“Rush Street”) which are both currently licensed plenary as casino service industry enterprises, for reasons set forth therein and more specifically regarding conduct from November 2021 until January 2024 in which Kambi and Rush Street had engaged in conduct that resulted in permitting wagering on events after the outcomes were already known as well as on pre-match markets for an event which had already started; and

Having considered the relevant provisions of the Casino Control Act, *N.J.S.A. 5:12-1*, et seq., the Sports Wagering Act, *N.J.S.A. 5:12A-1*, et seq., and the relevant regulations promulgated thereunder, *N.J.A.C. 13:69D-2.3(c)*, *N.J.A.C. 13:69N-1.9(j)*, and *N.J.A.C. 13:69N-1.9(n)*; and

Having considered the remedial action taken by Kambi and Rush Street in response to these violations; and

Having considered the Stipulations of Settlement which the parties executed and finding sufficient legal and factual support for the recommended penalties therein.

I hereby **ORDER** that the settlements be adopted and that a civil penalty in the amount of \$10,000 be imposed upon Respondent Kambi and a civil penalty in the amount of \$10,000 be imposed upon Respondent Rush Street payable upon receipt of invoices from the Division's Revenue Unit.
