Petition of Evolution New Jersey LLC
To Offer Spanish-Language
Blackjack Table Layouts at
Live Dealer Studios

ORDER
PRN 3052302

By its Petition, PRN 3052302, to the Division of Gaming Enforcement (“Division”), Evolution New Jersey, LLC (“Evolution”) requested permission to offer Spanish-Language Blackjack Table Layouts for its Spanish-Language Blackjack at both of its Live Dealer Studios located at Boardwalk 1000, LLC d/b/a Hard Rock Hotel and Casino Atlantic City and A.C. Ocean Walk, LLC d/b/a Ocean Resort Casino. The Division approved Spanish-Language Blackjack at both Live Dealer Studios on October 16, 2023, under PRN 0412302. The Division approved Spanish-Language Blackjack Table Layouts on January 5, 2024, under PRN 3052302.

Evolution now seeks to alter its Spanish-Language Blackjack Table Layout for its Spanish Language Blackjack in accordance with Condition #4. Evolution seeks to eliminate the Layout approved by the Division on January 5, 2024, and shown in Exhibit 2. Evolution proposes a new Layout as presented in Exhibit C.

Having considered the relevant provisions of the Casino Control Act, *N.J.S.A. 5:12-1 et seq.*;

It is hereby **ORDERED** that the Petition be granted; and that

This approval is subject to the following conditions:

1. Evolution will continue to conduct all Spanish Blackjack in its Live Dealer Studios in accordance with the Division’s Regulations.

2. Evolution will continue to conduct all Spanish Blackjack in its Live Dealer Studios in accordance with the descriptions and representations included in PRN 0412302.
3. The January 5, 2024, approval of the Spanish Blackjack Table Layout as depicted in Exhibit 2 of PRN 3052302 is revoked.
4. The Spanish Blackjack Table Layout as depicted in Exhibit C of PRN 3052302, dated March 1, 2024, is approved. Any proposed change(s) or deviation(s) from this layout must be submitted to the Division for review and approval.
5. Evolution has a continuing responsibility to ensure proper game play for all Spanish Blackjack games in its Live Dealer Studios.
6. All conditions imposed upon PRN 0412302, except Condition #9, remain in full force and effect.
7. Evolution has a continuing responsibility to ensure compliance with all Division Regulations and the Casino Control Act.
8. If at any time Evolution violates any of these enumerated Conditions, the Division reserves the right to revoke this authorization.
