LETTER ORDER WITHDRAWING VENDOR REGISTRATION

RE: Request of R-GA Media Group, Inc. (VRF #94901) for Withdrawal of its Vendor Registration

ORDER NO. 2744

Dear April Quinn:

On April 20, 2023, R-GA Media Group, Inc. ("R-GA"), a digital advertising company, filed a vendor registration form ("VRF") through Borgata Hotel, Casino, and Spa. Thereafter, on September 27, 2023, R-GA filed a vendor registration supplemental disclosure form ("VRSDF").

Pursuant to *N.J.S.A.* 5:12-76, the Division of Gaming Enforcement ("Division") commenced an investigation of R-GA and its qualifiers as disclosed on the VRF. Thereafter, on April 12, 2024, the Division received an email formally requesting the withdrawal of R-GA's vendor registration from R-GA's Executive Director.

The Division conducted a preliminary investigation of R-GA and its qualifiers prior to the receipt of this withdrawal request. The results of that preliminary investigation, although incomplete, reflect no substantive derogatory information since the completed vendor registration filings were submitted

R-GA has transacted \$94,436 in business with the Atlantic City casinos in the previous 12 months, with the last reported transaction occurring in January 2024.

Therefore pursuant to *N.J.A.C.* 13:69A-8.6(a), it is hereby **ORDERED** that the vendor registration of R-GA is **WITHDRAWN**.





It is further **ORDERED** that R-GA be removed from the Active Vendors List pursuant to its request.

It is further **ORDERED** that pursuant to *N.J.A.C.* 13:69A-8.6(a), R-GA shall not be eligible to apply again for licensure, registration, or approval until the expiration of one year from the date of this Order.

It is further **ORDERED** that the granting of this withdrawal is without prejudice to any position that the Division may take regarding any subsequent applications or registrations which may be made by R-GA.
