Dear Satvinder Bhens:

In accordance with N.J.A.C. 13:69J-1.14A and N.J.A.C. 13:69J-1.14B, you, as Chief Technology and Product Officer of Entain PLC, a casino service industry enterprise (“CSIE”) licensee, Director of BetMGM LLC, as well as a qualifier of Stadium Technology and bwin.party USA Inc., all three of which are CSIE licensees, filed the appropriate qualifier forms and were designated a pendent qualifier of the entities. As set forth by regulation, a pendent qualifier is required to establish plenary qualification within 18 months.

The Division has investigated your suitability for qualification and finds that you have established your financial stability, integrity, and responsibility, as well as good character, honesty, and integrity, as is required by N.J.S.A. 5:12-89b(1) and N.J.S.A. 5:12-89b(2), incorporated by reference by N.J.S.A. 5:12-92b, and should therefore be deemed to have established plenary qualification in connection with the casino service industry enterprise licensees.
