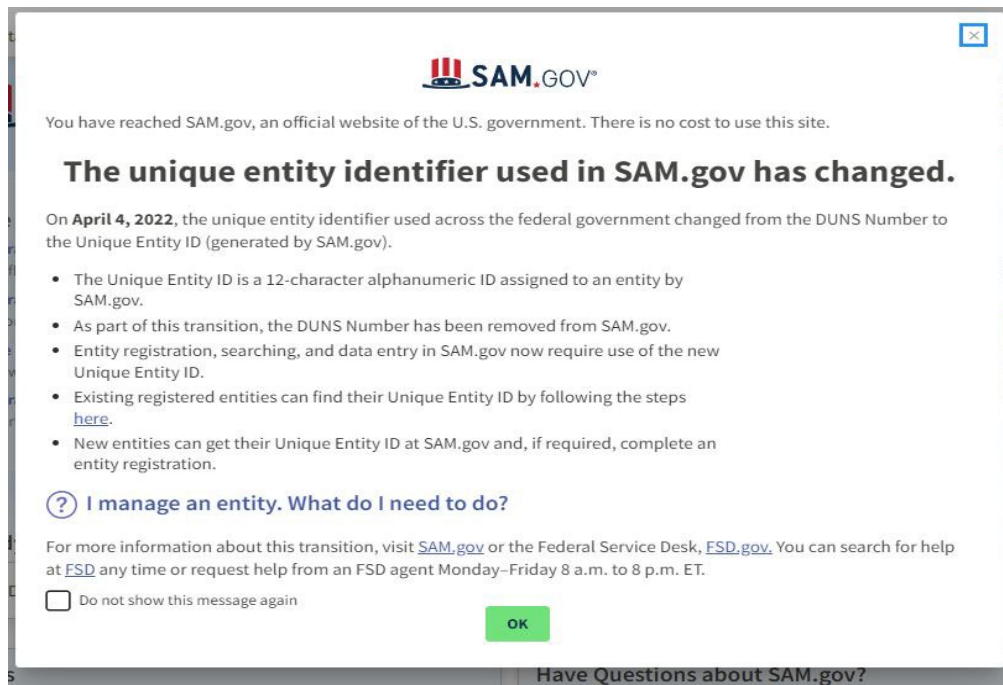
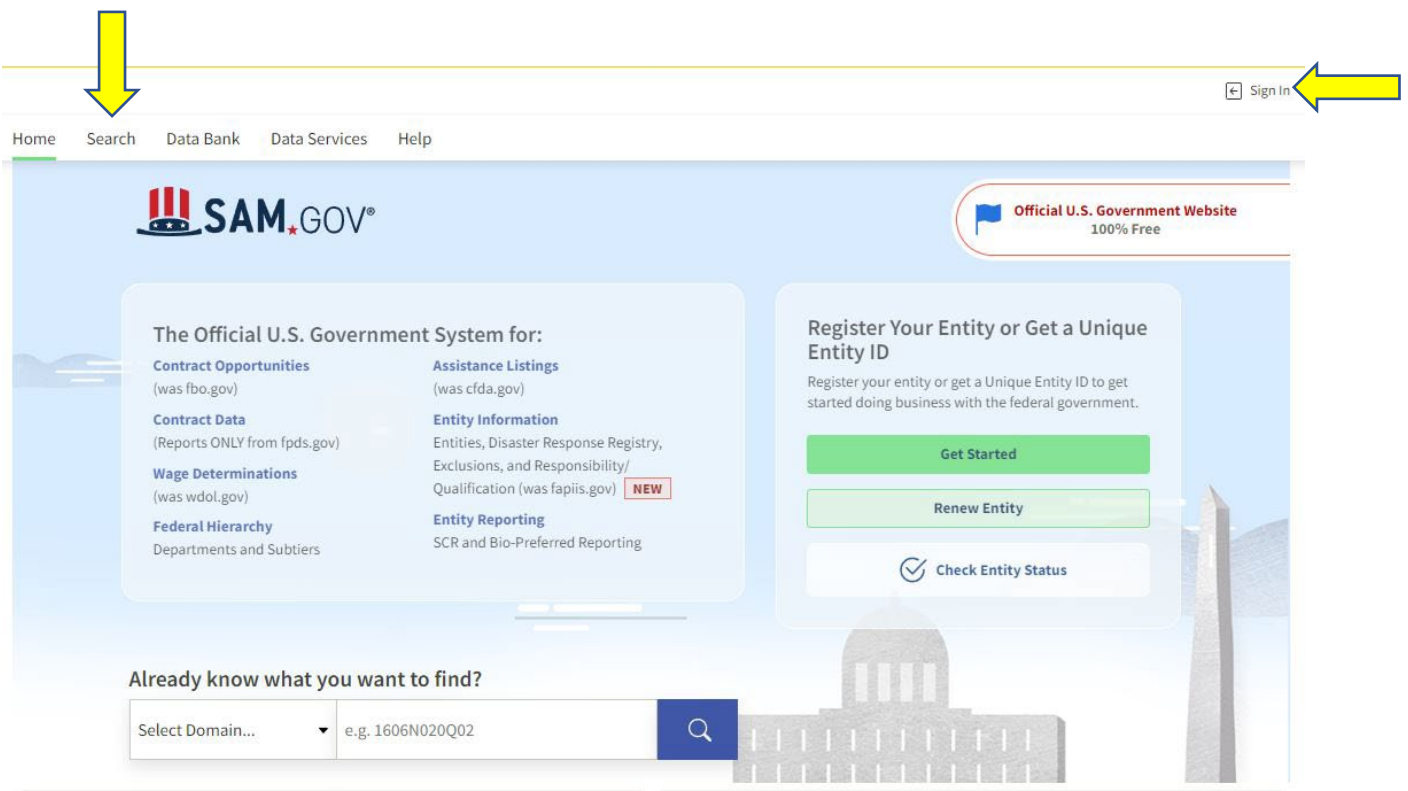


## HOW TO SUBMIT PROOF OF ELIGIBILITY TO RECEIVE FEDERAL FUNDS
