Notice of Availability and Award of Funds

Federal Fiscal Year (FFY) 2021 Victims of Crime Act Grant Program

Take notice that in compliance with the Federal Victims of Crime Act (VOCA) of 1984, 34 U.S.C. §§ 20101, et seq., the Department of Law and Public Safety (Department) announces the availability and award of the following non-competitive subawards funded by FFY21 VOCA program funds:

Non- Competitive Victim Assistance Grants

\$8,508,469

Under this program, \$8,508,469 in continuation grant funding may be offered and awarded to the to the following non-profit victim services agencies. Continuation funding will be limited to those subrecipients who were funded under the FY21 VOCA VAG Competitive Program, and who have met the goals and objectives of the program, successfully expended federal funds, met all reporting requirements in a timely manner, and any other factors that DLPS may take into consideration.

Funding is provided for services to all victims of crime, is on a reimbursement basis only, and is contingent upon subrecipient application submission, compliance with grant conditions, and satisfactory performance of services. The funding is for a 12-month period from September 1, 2024 through August 31, 2025. Applicants may only apply for up to the maximum federal funding amount listed below. Grant period extensions will not be permitted.

A 20 percent match, cash or in-kind, is required by all applicants. For example, a \$137,500 award requires a \$34,375 match for a total project cost of \$171,875.

If you are unable to fulfill the match requirement, the Federal Office for Victims of Crime (OVC) may grant a full or partial waiver on a case-by-case basis. To be considered, submit a match waiver request justification letter as part of your application package (refer to Program Guidelines); your inability to meet the full match amount will not negatively impact the strength of your overall application.

The Federal Funding Accountability and Transparency Act (FFATA) of 2006 requires agencies to register with the System for Award Management (SAM), formerly the Central Contractor Registration (CCR), to receive a Unique Entity ID (UEI), for all entities applying for a federal award or subaward.
